Director O'Connell explained this item and the next item relate to economic development activities paid by the Intergovernmental Revenue Sharing (sewer) funds. Ordinance requires the Authority make a recommendation to council regarding the use of those funds. Racine County Economic Development Corporation (RCEDC) provides economic development services to the City for these initiatives.

Gordy Kacala, Director of RCEDC, spoke. He indicated that RCEDC provides staff for the commercial corridors including Douglas Ave., State St., Uptown and West Racine via Kristin Niemiec. RCEDC also provides services to obtain grants for clean-up of contaminated property such as the Jacobsen property through staff person Tina Chitwood. Kristin Niemiec presented a memo of 2009 accomplishments and a 2010 work plan.

A motion was made by Commissioner Mason, seconded by Commissioner Lange, to adopt resolution 10-04. The motion PASSED by a voice vote.
