**Subject:** Communication from Focus on Community requesting to use city right-of-way for a run/walk on September 7, 2013. (Res. No. 13-0304)

**Recommendation of the Public Works and Services Committee on 7-30-13:** That Focus on Community be granted permission to use city right-of-way for a run/walk on Saturday, September 7, 2013, from 9:00 a.m. to 12:00 p.m.

Further recommends that permission be granted with the following stipulations:

- A. A hold harmless agreement be executed and a \$75.00 processing fee paid.

**Recommendation of the Finance & Personnel Committee on 8-12-13:** Permission be granted to the Root River Council, Inc. to host the first annual River Fest at Island Park on Saturday, September 21, 2013 from 2:00 p.m. until 11:00 p.m. without abatement of fees.

Ben Lehner recused himself from voting on this item and spoke on behalf of the Root River Council, Inc. The proposed festival scheduled for September 21st will be modeled after the Chautaugua's of the early 1900's. Molbeck stated there were concerns in regards to the original proposal to place the petting zoo and shows on

the ball diamond. Lehner stated their goal is now to have everything on the east side of the road. Molbeck requested staff work with the organization in regards to the layout and also noted they need to be out of the park by the 11:00 p.m. closing. McCarthy asked Lehner if he was open to any other areas or locations. Lehner stated he was, however the walkway, the river, access to restrooms, the pavilion and the ability to provide limited access if needed are all advantages of having the festival at Island.

A motion was made by Kristen Kaprelian, seconded by Christina Mueller, that the recommendation be approved. The motion PASSED by voice vote.

# Discussion: Bike Jam Event

Molbeck opened a discussion regarding the past practice of the Bike Jam event & the decline in volunteer hours provided by the event organizer. It was agreed a hold harmless agreement and insurance must be provided for this years event. Beginning next year applicable fees, insurance and a hold harmless agreement will be required. It was also noted by McCarthy that additional portable toilets be brought in by the event planner for the event.

# **Discussion: 2014 Budget**

Molbeck stated PRCS is currently mediocre in many programs and activities. The goal is to take a few and make them great. He had recreation staff prioritize all current programs & activities. Park staff will undergo the same process with the parks. A listing of the prioritized programs and parks will be provided to the board at the September meeting per McCarthy's request.

There was also a brief discussion in regards to the 2014 fees & charges. Ald. Sarrazin believes the charge for the playground program could increase next year. The program runs Monday through Thursday over the course of several weeks.

LeGath commented that perhaps the beer permit fee could be increased as well.
