Recommendation of the Public Works and Services Committee on 9-29-09: That the roundabout, as presented for the final intersection design, including the center island wall be approved.

**Fiscal Note:** Funding for the roundabout is included in the Seventh Street Reconstruction Project.

Rick Jones read a letter from the consultant, AECOM, noting the Citizens Advisory Committee recommended the round-about as the preferred intersectional alternative to the intersection of 6th Street, 7th Street and Grand Avenue. He also noted the Citizens Advisory Committee recommended the all-landscape walls, part of the streetscaping improvements in the center of the round-about, as well.

Rick Jones gave background information on 6th and 7th Streets one-way study and the improvement project currently underway on 6th Street. He noted the improvements in pedestrian and vehicle safety. A video simulation was shown with the round-about modeled with projected traffic counts in the year 2031, along with full streetscape in the daytime and nighttime simulation.

After further discussion, a motion was made by Hart, seconded by DeHahn to approve the CAC's recommendation for the round-about at the subject location, along with the landscape retaining wall in the center of the round-about. Passed unanimously.

He typically noted that whenever improvements are made in intersections that require curb and gutter to be worked on near radius returns, all corners are upgraded with ADA accessible ramps at that time. However, he did note these requests can be handled on an individual basis as they come in and noted they would be placed on the 2010 contract.

John Rooney read a memo regarding the 2009 Pavement Management System Summary Report submitted to the City of Racine by AECOM Technical Services. He noted the report included the type of road classifications and materials, as well as the inspection program for the City of Racine. He noted the inspection process to determine rehabilitation strategies and noted the replacement value of the City network in 2009 dollars, as well as useful life value and noted that pavements are losing approximately \$6 million per year in value. He noted this is a useful tool in budgeting for the Capital Improvement Program, as well as Operations and Maintenance. He then presented a PowerPoint presentation showing some of the results of good pavement management practices.
