Brenda Torres appeared. Chairman Helding informed committee members they should have requested a packet from the applicant with all of the requested information from the last meeting. Ms. Torres was questioned on the capacity limits and she stated she had been informed by the building department the capacity would be 100-120 because they have 3 bathrooms. She stated that in their packet there was a letter from the owner of the car wash next door stating he would allow her to use his parking lot. There were some questions whether or not the person owns the car lot business and it was later discovered that he is leasing the building on a land contract and has the authority to allow them parking. Committee members questioned how she will obtain her bouncers and she stated she was waiting to see if the license would be granted before pursuing that option, but she had spoke to several individuals on this.

Alderman Kaplan stated that there may have been some pressure and coercing placed on those people who signed the petition. He also stated that he has a problem with the traffic patterns in the area. He stated he does not feel this business would be a good fit for the area.

Alderman Fair stated that the applicant has went and done the homework the committee requested of her. He stated the alderman of the district is being negative before the business is even started. He stated all the provisions the committee requested have been met.

Chairman Helding made a correction that the 30 and older age limit should have been 25 not 30 as printed in the last minutes.

Motion made by Alderman Mozol seconded by Alderman Kaprelian-Becker to deny the license due to concerns of security, and too many alcohol licenses in the area.
