Subject: Communication from the Alderman of the 5th District wishing to amend the flag policy for the City of Racine.

Recommendation of the Public Works and Services Committee on 11-24-09: That the flag policy, as approved under Resolution 08-0726 of April 2, 2008, be amended to include flying the flag at half staff for the death of active duty military personnel from Racine County.

Chairman Helding started the discussion that the City didn't lower the flag for the soldiers that were killed at Ft. Hood. This prompted a discussion regarding the Governor's and the President's orders to lower flags.

Rick Jones noted the City typically follows these orders.

Recommendation of the Public Works and Services Committee on 11-24-09: That the item be received and filed.

Fiscal Note: N/A

Jason Herzog, from the City Engineer's Office, did a presentation on the storm sewer GIS capabilities. He noted some of the attribute data that was tied to the City's storm sewer GIS. He noted the City can now click on pipe segment data in the GIS and run video clips from closed circuit sewer televising. He noted these hyper-links were part of the new changes done by the City of Racine, with respect to GIS. Jason further described some of the attribute data that was collected either from digitizing records and closed circuit televising. He noted all CCTV contractors use standardized PACP coding for pipe deficiencies. He noted these deficiencies are denoted and a rating scheme is set for the City of Racine to analyze what pipes need what type of rehabilitation.

John Rooney noted it was similar to pavement condition index and using that number to rate pavements to determine which pavements need rehabilitation.

Jason Herzog noted this work was done in conjunction with the paving program so the City is looking at all underground infrastructure when deciding which streets to pave. He further demonstrated the City's ability to trace up and down stream lines that have been digitized in the GIS. He noted if illicit discharge was detected at an outfall in the river, that sewer line could easily be traced in the City's GIS to every pipe segment and manhole that ultimately discharges to that outfall point. He noted

conversely if there was a spill at a certain location, the City could very quickly trace all sewer and structures that are downstream of that spill location to try to mitigate spill problems. He noted the possibilities are almost endless for the type analysis that could be done.

After further discussion, a motion was made by Hart, seconded by DeHahn to receive and file the report. Passed unanimously.
