REPORT FOR THE MONTH OF JULY:

Highlights:

- Ms. Sandy Poehlman, contract administrator from the Department of Health and Family Services Southeast Regional office in Milwaukee, conducted a mid-year review of the consolidated grant objectives on July 30th. Lead program staff, Bioterrorism preparedness staff and Worksite Health Promotion staff met with Ms. Poehlman and reviewed our mid-year reports. All programs are on target to meet or exceed goals.
- Twenty-four soft serve ice cream samples were taken in July, 14 samples passed and 10 samples failed. Follow up is being done for the samples that failed.
- In July, Zoo and North Beaches had no closures or advisories. Beach status information is available on the City of Racine website and also on the Beachhealth website through the United States Geological Survey.
- July 25, 2007, Mr. Robert Carlson presented lead poisoning prevention information to a First Time Home Buyer education class. The class was sponsored by Housing Resources, Inc. and had 17 participants. First time home buyer education is a prerequisite for many of the home buyer assistance programs that are available in the City of Racine.

Outcome Achievements:

- Two hundred and eighty (280) children tested for lead poisoning had blood lead levels between zero and nine ug/dL (0-9 ug/dL).
- Preliminary reports identify that one hundred and twenty five (125) children were <u>first</u> tested for lead poisoning; One (1) had an elevated blood lead level (>9ug/dL), or 0.01%.
- Preliminary reports identify a <u>total</u> of two hundred and ninety three (293) children as being tested for lead poisoning; thirteen (13) had an elevated blood lead level (>9ug/dL), or 4.4%.
- The number of 2007 city dog licenses obtained to date is four thousand fifty-two (4052).
- The number of 2007 cat licenses obtained to date is nine hundred and (913).
- Ninety-five (95) pet fanciers' permits have been issued in 2007.
