**Subject:** (Direct Referral) Review of applications for 2015 Community Development Block Grant (CDBG) and Emergency Solutions Grant (ESG) funding. (Res. No. 15-0285)

**Recommendation of the Community Development Committee on 6-18-15:** That the recommended allocation, as amended, of the 2015 Community Development Block Grant (CDBG) and Emergency

Solutions Grant (ESG) be approved; and, that the appropriate city officials be authorized and directed to execute and submit to the U.S. Department of Housing and Urban Development the documents required to secure the grants; and that the appropriate city officials be authorized to execute third-party contracts with the agencies approved for the use of the funds.

**Fiscal Note:** The recommended allocations are attachments to this item. This action allocates \$2,135,225 in Community Development Block Grant funds including administrative expenses, and \$152,315 in Emergency Solutions Grant funds, including administrative expenses.

Anguiano asked staff how WWBIC was performing as an existing microenterprise development organization and staff responded that they have performed well with no monitoring findings or concerns. Staff further stated that while WWBIC is high performing grantee, the Hispanic Chamber of Commerce offered a new street outreach program that targets a growing and underrepresented group that may be unaware of business services that are available to them. Anguiano then stated it was a better idea to fund a known group with a good performance record rather than lower the groups' funding in order to fund a new organization (the Hispanic Chamber of Commerce). Frasher agreed. Campbell disagreed given the increase in the Hispanic population in Racine.

Frasher moved and LeGath seconded an amendment to the budget as presented by staff to remove funding to the Hispanic Chamber of Commerce and give all Microenterprise Program funding to Wisconsin Women's Business Initiative Corporation.

Additional discussion: Ald. Perez commented on the lack of funding for the King Center in the proposed budget. He suggested that if the City wants to show support for GED education programs it should be including it as a city program held at city facility, and improving the program if it is not performing well. Staff noted that, overall, agencies that partnered together on their applications tended to produce more value for the money and leveraged additional resources. Staff asked Perez if he would have fewer reservations about this issue if the literacy programs partnered together and utilized city owned community centers to provide services. Perez responded in the affirmative.

Motion to amend the staff recommendation carried on a voice vote.

A motion was made by Mr. Frasher, seconded by Mr. LeGath to amend the budget as presented by staff to remove funding to the Hispanic Chamber of Commerce and give all Microenterprise Program funding to Wisconsin Women's Business Initiative Corporation. The motion PASSED by the following vote:
