Tuesday, December 9, 2025

Rhino Bar - 1659 N. Main St - Officers self dispatch in reference to a building check. Business was closed and appeared to be secured. A license premise report was not completed due to the business being closed. **25-058319**

While officers were on scene the staff was unable to work the security footage and no victims were located. Throughout the investigation it was learned two staff members were assaulted as they were trying to break up the fights. Broken glass was located inside the bar and also it appeared pepper spray was used during the fight.

After the incident, several videos surfaced via facebook in reference to the fight that took place. It appeared multiple parties were involved and the incident took place inside the bare.

A license premise report was completed and no violations observed at the time of the report.
