Experience

Del is a real estate specialist responsible for real estate acquisition and relocation plan development and assistance for WISDOT, community development authorities, municipal and other state agencies. He has expertise in all aspects of public and private real estate transactions including WisDOT Real Estate procedures, market value estimates, negotiations, relocation plans and services and all applicable state eminent domain statutes.

In his career in real estate, Del has completed major WisDOT projects including the Marquette Interchange relocation and City of Burlington LPA redevelopment project. He has worked with other municipalities such as Pleasant Prairie I94 corridor, City of Glendale Bayshore Mall redevelopment project, City of Cudahy and City of Waukesha redevelopment projects. Del has also provided real estate services for MMSD flood mitigation projects and WE Energies acquisition and relocation services. Del also served as a real estate specialist/agent for the City of Milwaukee's Department of City Development. He provided professional real estate services to all city developments including Milwaukee Public Schools, the Port of Milwaukee, Redevelopment Authority and Housing Authority of the City of Milwaukee, both in the acquisition and disposition of real estate. Specifically, Del has prepared Residential Acquisition Stage Relocation Plans and provided relocation assistance for the over 275 residential displacees and over 100 businesses in cities such as Waukesha, Wauwatosa, Glendale, Milwaukee, Villages of Fox Point, Pleasant Prairie and Jackson, and MMSD and We Energies -- a Wisconsin-based utility. He also prepared an Acquisition Stage Relocation Assistance plan for the over 50 potential business displacees in the Bayshore Mall Redevelopment Project, known as Bayshore Town Center. Del prepared a Conceptual Stage Business Relocation Plan for the Indiana Department of Transportation for over 90 business parcels for the I-70 and 65 corridors around Indianapolis, Indiana.

A sample of some detailed relocation experience includes:

Canal Street Expansion/Reconstruction Project, Milwaukee (WisDOT ID 2984-25-02) Hank Aaron State Trail, Milwaukee (WisDOT ID 2984-09-29)

Del served as Real Estate Specialist for this fast-track project, located in Milwaukee's Menomonee Valley. The project included design for the reconstruction of 1.3 miles of existing roadway and 1.5 miles of new road. An integral component of the reconstruction was the removal and relocation of railroad tracks that run down the center of the current roadway. Canal Street is expected to play a critical role in maintaining mobility and economic vitality of Milwaukee's downtown during reconstruction of the Marquette Interchange. Del was responsible for relocation assistance and services for over 60 storage unit tenants on this project.

Pleasant Prairie Frontage Road

As a Real Estate Specialist and project manager for the separation of the west frontage road and the on-ramp of I-94 between the CTH C and STH 165 in the Village of Pleasant Prairie, Del was responsible for the Relocation Plan, Relocation Services and Relocation Assistance. Marquette Interchange WisDOT Project

The Marquette Interchange consists of I-94, I-794 and I-43 and is considered the cornerstone of the southeastern Wisconsin freeway system. The project will be constructed in four years from 2004 to 2008. Construction began in fall 2003 and is scheduled for completion in fall 2007, with 15-20 construction packages expected. Program costs totaling \$850 million. As a Real Estate Specialist, Del was responsible for all relocation services for this improvement project including relocation of glove company and massive auto towing and salvage lot. This project was completed on time for the letting date and included obtaining a writ of assistance for the auto towing business.

Bayshore Mall, Glendale, WI

Real Estate Specialist on this joint venture between the City of Glendale and the owners of Bayshore Mall to rehabilitate the mall, abutting parking structures, public utilities and public roadways.
