**RE: LICENSED PREMISE REPORT**  
October 2006

Dear Ms. Johnson-Martin,

The following report reflects calls for service regarding Licensed Premises which have been submitted to Investigator Jody Spiegelhoff.

**1301 Washington Avenue                      The Warning Track**

On 10-29-06 Jason Hansen reported to police that Scott Hansen, owner of The Warning Track, assaulted him while inside the bar. Jason reported that Scott is his father and that he helped him out on October 28-29. Scott, Shari (his wife) and Ruben Fuentes arrived at the bar at about 11:30 pm, and Scott was highly intoxicated, according to Jason. At about 2:15am, Jason began getting customers out of the bar to abide by closing hours. Jason and Scott got into an argument over closing the bar, and Scott told Jason to "get the fuck out" of the bar. Jason then tried to collect his tip jar, when Scott came behind the bar and began punching Jason in the face. Jason further reported that he put his arms up in defense, however, Ruben put him in a "sleeper hold" and Scott punched him in the face about 12 times. Jason stated to police that he got up and walked out of the bar and got into his truck to leave, however, Ruben pulled him out of his truck. Jason's cell phone was also taken away by Ruben and Scott during this time. Jason then fled on foot down Washington Avenue and flagged down an officer.

The reporting officer advised that Jason had visible injuries all over his head, neck and body and that his injuries were consistent with his detailed statement, even 2 hours after the incident occurred. The reporting officer also stated that Jason's injuries were not consistent with being held back, as Ruben reported to police. The reporting officer also stated that the two witnesses, Shari (Jason's Mother) and Ruben only gave vague statements about what happened and stated they didn't want anything done to either party. Scott could not be located that evening.

The reporting officer completed a warrant recommendation for Scott Hansen based on all the factors, which was submitted to the District Attorney's Office. The status of the warrant recommendation is unknown at this time.

There were no other noteworthy incidents during the month of October.

## Alcohol and Tobacco Compliance Checks

On 10-07-06 the Racine Police Department conducted compliance checks on various establishments within the city of Racine. During a check of 15 different city establishments, 10 actually sold tobacco, alcohol or both to an underage (high school student) volunteer. Two of the establishments' clerks (Total 24 and Olympic Liquors) sold to the volunteer twice. These establishments and clerks are highlighted in red and *italics*.

### **Total 24**

During the first sale to the underage volunteer at Total 24 at 10:24 am, Irina Manhani sold cigarettes without checking for identification. During the second sale to the underage volunteer at 1:22 pm, Irina Manhani sold a 6 pack of Miller Genuine Draft 16 oz cans to the underage volunteer without checking for identification. Irina was cited for each violation (2 UMCC's) on a later date, as not to draw attention to our volunteer.

**Olympic Liquors**

During the transaction at Olympic Liquors, the underage volunteer was allowed to purchase a pack of Newport's and a 6 pack of 7 oz bottles of Corona Beer from an Indian male, later identified as Moheyeldien, who did not check for identification. On the volunteer's way out of Olympic Liquors, it was noticed that there were only 5 bottles of Corona in the 6 pack that was purchased. Therefore, the volunteer re-entered the store to have the problem corrected. While the volunteer was in the store, the female clerk, Jarnail Singh, sold a 1.75 liter bottle of Vodka without checking the volunteer's ID. Moheyeldien was cited for each violation (2 UMCC's total) on a later date, as not to bring any attention to our volunteer. Jarnail Singh could not be cited. Officers were told that she went back to Egypt.

It should be noted that as of Oct. 31<sup>st</sup>, the following clerks had not been served their UMCC's:

The rest of the violators were cited after the date the compliance checks were completed, as to not draw attention to our underage volunteer.
