**Thursday, November 13, 2025**

**Uptown Pub and Grill** - 1510 Junction ave - Officers were dispatched in reference to a civil trouble. Dispatch advised party was causing a disturbance and threatening the bartender. Party was located and cited for disorderly conduct. License premise report was completed and no violations observed. **25-054017**

**Friday, November 14, 2025**

**Buckets Pub 2nd Round** - 2031 Lathrop Ave - Officers were dispatched in reference to a party attempting to get into locked vehicles in the parking lot. Officers eventually located the party and was taken into custody. License premise report was completed and no violations observed. **25-054182**

We located large amount of blood in front of the bar and also a party suffering a laceration to the arm. Party did not want to speak to police and left the area. It should be further noted a party who advised he was the owner of the bar was extremely argumentative with law enforcement. As I arrived on scene, I made contact with the male party and continued to argue with me. Party demanded that we have law enforcement outside of his bar due to him calling. At one point, party who advised was the owner told me to "F-you". A license premise report was completed.

**Pub on Wisconsin** - 525 Wisconsin Ave. - Officers were dispatched in reference to a civil trouble. Prior to police arrival dispatch advised a caller was advising someone dropped a firearm. Once officers arrived on scene, the problem appeared to have been resolved. A license premise report was completed. **25-056035**
