Alderman Wisneski represented several residents living on the 100 block of Virginia St. which had sewer back-ups in their basements due to the recent heavy rains. He stated that several people in this area had damage to the contents of their basements and were looking to the Wastewater Utility for help to relieve the sewer back-up problems.

Subject: Professional Services Contract with Earth Tech to Investigate Sewer System Deficiencies and Feasible Solutions for Mitigation of Basement Back-ups - Jim Kunz invited to the meeting

Mr. James Kunz from Earth Tech submitted a professional services contract to investigate sewer system problems and possible solutions to handle basement sewer back-ups. Mr. Kunz was present to explain that the reason for the back-ups in the area of Virginia St. was because they were in a low-lying area of the city. He went on to say that Earth Tech would evaluate the areas of Virginia Street and Michigan Boulevard and make recommendations for fixing the sewer back-up situations. He noted that the estimated cost of the investigation would be \$16,000.00.

Commissioner Lui made a motion, seconded by Commissioner Staeck, to approve the

proposed professional services contract submitted by Earth Tech for the purpose of investigating sewer system deficiencies and feasible solutions for mitigation of basement back-ups. Furthermore, that this study is not to exceed \$20,000.00. The motion passed unanimously.
