INTERDEPARTMENTAL AGREEMENT BETWEEN THE OFFICE OF THE MAYOR AND THE FINANCE DEPARTMENT

THIS INTERDEPARTMENTAL AGREEMENT ("Agreement") is made between The Office of the Mayor of the City of Racine ("Mayor's Office") and the City of Racine Finance Department ("Department").

WHEREAS, the 2021 American Rescue Plan Act ("ARPA") provided funding to the City from the Coronavirus State and Local Recovery Fund ("SLFRF"), (hereinafter called "ARPA funding");

WHEREAS, the U.S. Department of Treasury is the federal agency that administers the ARPA funding and has provided the City with the ARPA funding conditional on the City complying with its rules and regulations;

WHEREAS, the City has established a process for City agencies and organizations external to the City to apply for ARPA funding;

WHEREAS, the Mayor Office has administered the process for ARPA funding and recommends the Department receive ARPA funding for its program as described in this Agreement;

WHEREAS, the Mayor's Office and the Department wish to enter into this Agreement to memorialize each other's responsibilities in regard to the ARPA funding for the program; and

NOW, THEREFORE, that in consideration of the mutual promises contained herein and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

A. <u>PURPOSE</u>

The Mayor's Office hereby agrees to provide ARPA funding, in the amount set forth herein, to the Department to facilitate the implementation of the program.

B. SCOPE OF PROGRAM

Department shall implement the program, including any milestones and deliverables, as described in **Exhibit 1**, which is appended hereto and made a part of this Agreement.

C. <u>TERM</u>

The term of this Agreement shall begin on December 1, 2024, and end on December 31, 2026, unless terminated earlier in accordance with this Agreement.

D. <u>FINANCIAL AND PERFORMANCE REQUIREMENTS</u>

- 1. Funding. Subject to the availability of ARPA funding, the Mayor's Office shall provide funds to the Department for the program, in an amount not to exceed (\$115,000) for the term. Any expenses/costs incurred by Department more than this amount shall be the sole responsibility of Department.
- 2. *Budget*. The Department agrees that all expenditures are to be in accordance with the approved budget for the term of this Agreement. The approved budget is part of the proposal at **Exhibit 1**.
- 3. Payment. The City shall make ARPA funding as specified in this Agreement available for use. The ARPA funding shall be used to provide the services described in this Agreement and in **Exhibit 1**. The Department shall comply with the ARPA funding requirements listed at **Exhibits 2** and **3**. Any ARPA funding advanced to Department prior to the execution of this Agreement which is related to this Agreement is subject to the terms and conditions of this Agreement.
- 4. *Reporting*. The Department agrees to provide supporting documents and corresponding reports as requested by the U.S. Department of the Treasury and the Mayor's Office to meet any reporting deadlines. The Department shall adhere to the instructions and format, including specific forms required by the Mayor's Office and the U.S Department of Treasury for the ARPA funding. Reporting terms and conditions are provided in **Exhibit 4**.
- 5. Audits. The Department shall comply with all applicable provisions of the federal Uniform Guidance (2 CFR 200), including the Cost Principles and Single Audit Act requirements. At any time during business hours and as often as the city, state, or federal agencies may deem necessary, there shall be made available to the government agency for examination, the Department's records with respect to matters covered by this Agreement. The Department shall permit city, state, or federal agencies to audit, examine, and make excerpts or transcripts from such records, and to make audits of all contracts, invoices, materials, records of personnel, conditions of employment and other data relating to matters covered by this Agreement.
- 6. *Records*. The Department shall retain records related to this Agreement for a period of five years after all funds have been expended or returned to the U.S. Department of Treasury, whichever is later.
- 7. Subrecipients and Grantees Prohibited. The Department shall not make ARPA funding available to any subrecipients or grantees.

E. <u>CORRECTIVE ACTION AND TERMINATION</u>

1. *Corrective Action*. Upon written notice, the Mayor's Office may require the Department to take corrective action so the Department is complying with city, state, or federal laws, regulations, or rules related to the ARPA funding for the program. Corrective action may

be required for but is not limited to instances in which the Department: (a) fails to file a report, (b) fails to meet performance standards, (c) fails to meet milestones or timelines, or (d) misuses funds. The Mayor's Office may require corrective action of the Department, including but not be limited to: (a) a written warning, (b) additional technical assistance, (c) additional monitoring, (d) program suspension, and (e) reduction/repayment of funding.

2. *Termination*. Either party may terminate this Agreement by giving to the other party written notification prior to termination. Upon termination, the parties hereto agree that all reports and supporting documentation required for services rendered pursuant to this Agreement shall be provided to the Mayor's Office forthwith. Any funds advanced to the Department for services not yet rendered shall be returned to the Mayor's Office immediately.

F. MODIFICATIONS AND AMENDMENTS

The Department may submit a written request to the Mayor's Office asking for (i) an extension to the term of this Agreement; and/or (ii) a budget reallocation not to exceed 25 percent of the ARPA funding for this program. The request shall include an explanation for why an extension and/or program budget reallocation is needed and be provided to the Mayor's Office at least 60 days prior to the expiration date of this Agreement. The request must include all required documentation to justify the need for an extension and/or reallocation. The Mayor's Office will approve or deny the request in writing. The Department may not expend the ARPA funding under a reallocated program budget until such time the Department has received written approval from the Mayor's Office. Any additional funds or other modifications may be added to this Agreement by written Amendment setting forth the modifications/amendments signed by the parties.

G. GENERAL PROVISIONS AND CONDITIONS

- 1. Compliance with Laws. The parties shall comply with all local, state, and federal laws, ordinances, rules, regulations, interim expenditure and annual report requirements, and applicable codes of ethics, pertaining to or regulating the services to be performed pursuant to this Agreement, including those now in effect and hereafter adopted. Any violation of such laws, ordinances, rules, regulations, or applicable codes of ethics by the Department shall constitute a material breach of this Agreement and shall entitle the Mayor's Office to terminate this Agreement immediately upon delivery of written notice of termination to the Department.
- 2. Nondiscrimination. The parties shall operate under this Agreement so that no person, otherwise qualified, is denied employment or other benefits on the grounds of age, sex, race, color, veteran's status, disabled veteran's status, religion, disability, national origin, marital status, gender identity, sexual orientation, familial status, or economic status except where a particular occupation or position reasonably requires consideration of these attributes as an essential qualification for the position. The Department shall post in conspicuous places, available to employees and applicants for employment, notices setting forth the provisions of this non-discrimination clause.
 - 3. No Duplication of Funding. The Department shall not use different sources of federal

funding to pay for the same services. The Department shall not use ARPA funding to pay for the same work that was reimbursed or paid by other sources of funding (e.g., FEMA or CARES funding).

- 4. *Governing Law and Venue*. This Agreement shall be construed by and governed under the laws of the State of Wisconsin and subject to the jurisdiction of a court of competent jurisdiction in Racine County, Wisconsin.
- 5. *No Assignment*. This Agreement shall not be assigned by the Department to another party without the prior written approval of the Mayor's Office. This Agreement shall be binding upon the parties hereto and their successors and assigns.
- 6. *Notice*. Any notice required or permitted under this Agreement shall be in writing, be delivered by a reasonable and verifiable means (e.g., in person, mail, or e-mail) and be considered delivered upon receipt of the other party.

- 8. *Incorporation*. The recitals and exhibits are hereby incorporated as part of this Agreement.
- 9. *Final Agreement*. This Agreement constitutes the entire, full, and final understanding between the parties hereto and neither party shall be bound by any representations, statements, promises, or agreements not expressly set forth herein.

SCOPE OF WORK

Keys to Financial Security Individual Development Account (IDA) Program

The Racine Financial Empowerment Center (FEC), established in 2020 as Wisconsin's first FEC, assists City residents in achieving their financial goals. The FEC envisions a community where all families have knowledge of their options and receive individual coaching to improve their finances. The final goal is to help families build financial skills to attain financial security.

The biggest challenges to achieving the American Dream are lack of savings and low credit scores. A program to help families overcome these obstacles combined with a financial incentive such as matching savings account, could help families be more financially stable. Individual development accounts (IDAs) are incentivized savings interventions that have been shown to have a large, positive impact on savings, financial hardship, and homeownership.

The "**Keys to Financial Security**" is a program that, among other things, will empower families to become better educated in financial matters, create healthy saving habits, lower debt, and prepare residents for homeownership. The IDA program will be limited to 50 participants for an estimated program cost of \$250,000. The City of Racine will provide a direct savings match of \$100,000 to support this initiative, as well as an additional \$15,000 for staffing. The remainder of the program will be funded through support from local financial institutions.

Program Overview:

- 1. Participants will commit to attending 12 monthly financial literacy seminars.
- 2. Participants will open a bank account. The city will deposit \$150 for every class attended. There is a \$200 bonus if there are no missed seminars (max earned \$2,000).
- 3. Earned savings will be deposited into an IDA account. The city will match \$2 for every \$1 deposit up to \$1000 (max earned \$3,000).
- 4. At the end of the program, the participant will have at least \$5,000 to use towards a downpayment for a home.

Use of Funds.

- a. Recipient understands and agrees that the funds disbursed under this award may only be used in compliance with sections 602(c) and 603(c) of the Social Security Act (the Act) and Treasury's regulations implementing that section and guidance.
- Recipient will determine prior to engaging in any project using this assistance that it has the institutional, managerial, and financial capability to ensure proper planning, management, and completion of such project.

- b. Any debts determined to be owed the federal government must be paid promptly by Recipient. A debt is delinquent if it has not been paid by the date specified in Treasury's initial written demand for payment, unless other satisfactory arrangements have been made or if the Recipient knowingly or improperly retains funds that are a debt as defined in paragraph 14(a). Treasury will take any actions available to it to collect such a debt.

Disclaimer.

- a. The United States expressly disclaims any and all responsibility or liability to Recipient or third persons for the actions of Recipient or third persons resulting in death, bodily injury, property damages, or any other losses resulting in any way from the performance of this award or any other losses resulting in any way from the performance of this award or any contract, or subcontract under this award.
- The acceptance of this award by Recipient does not in any way establish an agency relationship between the United States and Recipient.

16. Protections for Whistleblowers.

- a. In accordance with 41 U.S.C. § 4712, Recipient may not discharge, demote, or otherwise discriminate against an employee in reprisal for disclosing to any of the list of persons or entities provided below, information that the employee reasonably believes is evidence of gross mismanagement of a federal contract or grant, a gross waste of federal funds, an abuse of authority relating to a federal contract or grant, a substantial and specific danger to public health or safety, or a violation of law, rule, or regulation related to a federal contract (including the competition for or negotiation of a contract) or grant.
- b. The list of persons and entities referenced in the paragraph above includes the following:

 - An Inspector General;
 - The Government Accountability Office;
 - A Treasury employee responsible for contract or grant oversight or management;
 - v. An authorized official of the Department of Justice or other law enforcement agency;

Every quarter, the Department will provide a narrative report on all project activities. Reporting frequency subject to change.
