There may be a new carrier coming to Racine and they could possibly be interested in placing their service on this pole as well. An electrical easement would not be needed if the City would be willing to charge the company for electric used. There are different options for the look of the antennas, i.e., a pod, or placing them on the side of the pole. It is possible that one slot could be made available to the City for it's future use. The tower would not be placed within the limits of the landfill at the park.

Kaplan said that he had done a lot of research on the history of the cannons and Monument Square and brought articles to show the Board. Further he said that he had received a lot of input and e-mails regarding the history of the cannons. He said he felt the cannons need to be there to get the full effect of the monument. Snow said that a former Board had some other recommendations for the placement of the cannons. The Landmarks Preservation Committee recently voted not to return the cannons to Monument Square. Ald. Weidner said that the person who started the cannon conversation was Sharon Baldukas of the Cemetery Board. Ms. Baldukas was trying to find the value of the cannons. Weidner said that the Cemetery Board would probably welcome the cannons at the Cemetery. Frontier noted that the Board had previously heard that the cannons were not always respected when they were on Monument Square.
