Saturday, May 10, 2025

R&V Night Club - 1224 Sixteenth St - Fight - Officer on patrol observed a fight on the sidewalk outside of the bar. 19 year old handed police a fake ID and admitted to drinking inside the tavern; cited accordingly. Initiated 0231 - Cleared 0341. **25-018820**
