**Subject:** (Direct Referral) Communication from Grace Church requesting use of Franklin Park for the Convoy of Hope Event from Thursday, September 15, 2016 through Saturday, September 17, 2016.

Recommendation from the Board of Parks, Recreation & Cultural Services on 1-13-16: To allow Grace Church use of Franklin Park for the Convoy of Hope event scheduled for Saturday, September 17, 2016. Further allow over night security to begin Thursday, September 15, 2016 for event set up.

Danny D'Acquisto, Director of Mission of Grace Church, presented the proposal to hold a Convoy of Hope event at Franklin Park on Saturday, September 17, 2016.

Lemke questioned how transportation would be handled. D'Acquisto indicated the area was chosen because it was centrally located in an area of need and therefore they are expecting foot traffic and others traveling via City bus. He advised there will be approximately 1,000 volunteers for the event. These volunteers would park at Grace Church and be shuttled to the event.

Hemmig inquired if the area residents, especially those directly surrounding Walden School and Franklin Park have been made aware of this event. D'Acquisto said they have not been. Molbeck recommended the residents be notified of this event by letter or flyer.

Molbeck expressed safety concern of street crossings, traffic at intersections, etc. due to the expected high attendance. D'Acquisto indicated Jim Vass will be handling the logistics of the event and contact has been made with the police department to assist with some of these concerns. Molbeck requested Vass reach out to the Parks department to discuss the logistics of the event.

DeGroot expressed participants should be made aware pets would not be permitted at Franklin Park.

A motion was made by Lemke seconded by Schaal to approve Grace Church use of Franklin Park for the Convoy of Hope event from Thursday, September 15, 2016 through Saturday, September 17, 2016 and further a allow security on-site overnight.
