We would like to request additional design fees of \$6,025 for work completed on the above-mentioned project. Please see below for a more detailed explanation of the additional design work performed.

Environmental Health & Nursing Layouts - \$1,650

Included with this project's Request for Proposal there were preliminary floor plan layouts, when we prepared our design proposal we budgeted time for a maximum of four meetings and sketches to finalize the layout of these areas. I've been doing this job for 20 years and found that in almost every case we can design a building layout that the owner will approve after 3 or 4 sketches, so we felt comfortable in this case. After the sixth meeting we verbally made note of these proceedings.

Due to several changes and additional offices, cubicles, etc. being added by the departments, we attended eight design meetings and in-turn prepared eight layout sketches. We have kept track of our time for meetings and layout sketches 5 through 8, see details below:
