Subject: Communication from Brian R. Exner, 2418 Westwood Drive, requesting permission to fill a ditch to develop a vacant lot on Spring Street between the Root River and 1723 Spring Place.

Brian Exner appeared before the Committee and stated he is developing a vacant lot into residential properties and indicated his options for parking would be to either install a retaining wall for the lot, or to grade a slope back from the top. The option to grade is cheaper, but it would require grading onto two city lands, and is requesting permission to do so. Rick Jones asked Mr. Exner to submit plans to the Engineering Dept. for review to see what impact the grading would have on the city property and any utilities in the area and requested the item be deferred.

- D. The property owner be charged a \$50.00 fee to cover costs associated with filing this item with the Register of Deeds.

Rick Jones described the ordinance and noted it is necessary to prevent disposing of

medical, hazardous or toxic waste curb side for the Solid Waste Department, and the associated forfeitures that go along with violating the ordinance. He noted this requirement is necessary to safeguard the Public Works Dept. when handling solid waste, as well as making sure these types of materials get disposed of properly.

He noted if Pointe Blue development were to occur, the CMAQ application would be to re-route the Lake Michigan Pathway around the perimeter of the site, along the breakwater up to the Coast Guard Station, and along the bulkhead on the north side of the Root River back to the intersection of Main and Dodge, near the Chartroom.
