Mr. Bester appeared and explained some of the incidents on the history report to committee members. He stated that he disputed about 4 of the 8 as they were "crowd control" calls and he didn't feel that should be associated with his establishment. He informed the committee that he wanted the same things that they were looking for. He states he employees 15 security guards and 3 off-duty police officers. He stated they started closing down @ 1:30a.m. because it takes them about 45 minutes to get the patrons out. He stated that he would like to see more enforcement from the police. Mr. Bester also wanted it known that they are still primarily a restaurant.

Alderman Kaprelian-Becker asked what steps had he taken since the last meeting when he appeared before the committee. Alderman Mozol suggested some changes to Mr. Bester like changing the age limit, limiting the number of patrons allowed.

After much discussion, the committee and Mr. Bester both agreed that they felt this lot should be changed to no overnight parking, the same as Uptown lot 5 in the area of 13th Street and Washington Avenue. It was determined that the City Clerk would enter a new communication from the Chairman of the Public Safety and Licensing Committee to the Transit and Parking Committee to meet requesting to change

Uptown Lot #1 located at 1422 Ann Street to the same restrictions as Uptown Lot #5 which is located at 1300 Washington Avenue. It was also requested that Alderman Wisneski and Alderman Shields be included on the item.

Alderman Helding made a motion seconded by Alderman Kaplan to receive and file the item. Motion carried.
