Ord.0913-06 ORDINANCE NO. 2-06 RELATING TO OFFENSES - GANG LOITERING

By Alderman Maack: ORDINANCE NO. 2-06

To create Section 66-114 of the Municipal Code of the City of Racine, Wisconsin relating to Offenses - Gang loitering.

The Common Council of the City of Racine do ordain as follows: Part 1:

Section 66-114 of the Municipal Code of the City of Racine is hereby created to read as follows:

"Sec. 66-114. Gang loitering.

(a) Whenever a police officer observes a criminal gang member engaged in gang loitering with one or more other persons in any public place designated for the enforcement of this section under subsection (b), the police officer shall, subject to all applicable procedures promulgated by the chief of police:

- inform all such persons that they are engaged in gang loitering within an area in which loitering by groups containing criminal gang members is prohibited;
- (2) order all such persons to disperse and remove themselves from within sight and hearing of the place at which the order was issued; and
- (3) inform those persons that they will be subject to arrest if they fail to obey the order promptly or engage in further gang loitering within sight or hearing of the place at which the order was issued during the next three hours.
- (b) The chief of police shall by written directive designate areas of the city in which the chief has determined that enforcement of this section is necessary gang loitering has enabled criminal gangs to establish control over because identifiable areas. to intimidate others from entering those areas, or to conceal illegal activities. The location of these areas shall be made public by publication in the local public access television channel. Prior to media and by announcement on a local making a determination under this subsection, the chief shall consult as he or she deems appropriate with persons who are knowledgeable about the effects of gang activity in areas in which the ordinance may be enforced. Such persons may include, but need not be limited to, members of the police department with special training or experience related to criminal gangs; other personnel of that department with knowledge of gang activities in the proposed designated area; elected and particular appointed officials of the area; and community-based organizations. The chief shall develop and implement procedures for the periodic review and update of designations made under this subsection.
 - (c) The chief shall by written directive promulgate procedures to prevent the enforcement of this section against persons who are engaged in collective advocacy activities that are protected by the Constitution of the United States or the State of Wisconsin.
 - (d) As used in this section:
- (1) Gang loitering means remaining in any one place under circumstances that would warrant a reasonable person to believe that the purpose or effect of that behavior is to enable a criminal gang to establish control over identifiable areas, to intimidate offers from entering those areas, or to conceal illegal activities.
 - (2) Criminal gang has the meaning as set forth in Wis. Stat. § 939.22 (9).
 - (3) Criminal gang activity has the meaning as set forth in Wis. Stat. § 941.38 (1)(b).
 - (4) Criminal gang member has the meaning set forth in Wis. Stat. § 939.22(9g).
 - (5) Pattern of criminal gang activity means two or more acts of criminal gang activity of which at least two such acts were committed within five years of each other.

- (6) Public place means the public way and any other location open to the public, whether publicly or privately owned.
- (e) Any person who fails to obey promptly an order issued under subsection
- (a), or who engages in further gang loitering within sight or hearing of the place at which such an order was issued during the three-hour period following the time the order was issued, is subject to a fine of not less than \$100.00 and not more than \$500.00 for each offense."

This ordinance shall take effect upon passage and the day after publication.

ORDINANCE NO. 3-06 RELATING TO PUBIC PASSENGER VEHICLES; TAXICABS.

ORDINANCE NO. 3-06

To create Secs. 22-1036(c) and (d), amend Sec. 22-1072 and Sec. 22-1073 of the Municipal Code of the City of Racine, Wisconsin relating to Public passenger vehicles: taxicabs.

The Common Council of the City of Racine do ordain as follows:

Part 1:

Secs. 22-1036(c) and (d) of the Municipal Code of the City of Racine is hereby created to read as follows:

"(c) Exclusive permission granted. Subject to the conditions and limitations of this chapter, exclusive permission and authority are hereby granted to taxicab provider licensees hereunder to operate taxicabs under this chapter upon the public streets and other public ways within the corporate limits of the city, unless terminated or revoked.

It shall be unlawful and the city will not permit any taxicab not licensed hereunder, or any person associated with such vehicle, to solicit business within the city or to accept for transportation, sightseeing tours or charter trips, any passengers within the city, excepting only passengers destined to the community in which such taxicab is licensed and then only when such transportation has been arranged for in advance by telephonic or written order.

(d) Number of available licenses. The license and welfare committee shall promulgate regulations to set forth procedures by which all available taxicab licenses shall be distributed periodically pursuant to open and competitive bidding procedures. The procedures shall be designed to produce the maximum amount of revenues to the city consistent with serving the public interest, and to ensure that the total number of licenses issued or to be issued depends on the public necessity for the designated level of service, and that only applicants that are qualified under this chapter are awarded licenses."

Part 3:

Sec. 22-1072 of the Municipal Code of the City of Racine is hereby amended by inserting in line 3 after the word "upon", the phrase "called in".

Part 4:

Sec. 22-1073 of the Municipal Code of the City of Racine is hereby amended by deleting in line 2 "a" and in line 3 deleting "radio" and inserting "communication" in its place.

Part 5:

This ordinance shall take effect upon passage and the day after publication.

Part 1:

Division 3, Department of Transportation, is hereby repealed.

Part 2

Sec. 2-531(e) and (f) of the Municipal Code of the City of Racine are hereby created to read as follows:

"(e) The commissioner of public works shall plan, develop, coordinate, operate and regulate the various elements of transportation and transportation facilities in such a way as to provide for the safe, efficient and economical movement of people and goods in the city. These responsibilities shall be those of mass transportation, traffic engineering and parking. It shall also be the duty of the commissioner to do research as necessary to guide the planning and operation of the city's street, traffic, parking and mass transportation systems and to assist in the formulation of traffic regulations; to install and maintain signs and markings; to install, operate an maintain parking meters; to install and operate traffic signals; to plan, operate, maintain and administer the city's street lighting program; to approve curb cuts and review building permits, and, as directed by the common council and transit and parking commission, to coordinate and assist in the management, operation and maintenance of the mass transit system and facilities. It

shall further be the duty of the commissioner of public works, or his representative, to serve as secretary of the parking and transit commission and of the traffic commission.

(f) The commissioner of public works shall cooperate with other city officials and departments in improving traffic facilitation and reducing traffic accidents and shall carry out additional powers and duties as may be imposed by ordinances of this city."

Part 3:

Sec. 94-163 of the Municipal Code of the City of Racine is hereby amended by deleting the first sentence in the paragraph, by deleting the phrase "traffic engineer" in the 16th line and inserting the phrase "commissioner of public works" in its place.

Part 4:

To amend the title of Chapter 114, Article VI, create Sec. 114-635, create Division 1. AC Access Corridor Overlay District, and create Division 2. FD Flex Development Overlay District, of the Municipal Code of the City of Racine, Wisconsin relating to Zoning.

The Common Council of the City of Racine do ordain as follows:

Part 1:

The title of Chapter 114, Article VI is hereby amended to read:

"ARTICLE VI. OVERLAY DISTRICTS"

Part 2:

Sec. 114-635 of the Municipal Code of the City of Racine is hereby created to read as

follows:

"Sec. 114-635. Generally.

Permitted uses of land or buildings authorized throughout this chapter shall be permitted in the various overlay districts as indicated in this section and others under the conditions specified. The following overlay districts are contained in this chapter: Article V. Division 4, Subdivision IV. I-P Industrial Park District; Article V. Division 5. Subdivision I. H Historic Properties District; Article VI. Division 1. AC Access Corridor Overlay District; Article VI. Division 2. FD Flex Development Overlay District; Article VII. Division 12. Downtown Design Guidelines; Article VIII; Flood Regulations."

Part 3:

Division 1. AC Access Corridor Overlay District, of the Municipal Code of the City of Racine is hereby created by inserting the following before Sec. 114-636 and by deleting the word "article" in the first line and inserting the word "division" in its place: "DIVISION 1. AC ACCESS CORRIDOR OVERLAY DISTRICT"

Part 4:

Division 2. FD Flex Development Overlay District, of the Municipal Code of the City of Racine is hereby created be inserting the following after Sec. 114-644:

"DIVISION 2. FD FLEX DEVELOPMENT OVERLAY DISTRICT

Sec. 114-645. Purpose and intent.

- (a) Over time, the use for which a property was developed may become obsolete due to economic, demographic, or technological change. The property, including structures, site improvements, and infrastructure, may have redevelopment potential for alternative use or uses. Flexible zoning regulations can facilitate the redevelopment of such properties, thereby minimizing vacancy and abandonment of property, promoting environmentally sound reuse of structures and infrastructure, and protecting surrounding property from adverse effects of new uses of the property that could occur if unregulated.
- (b) The flexible development overlay district is intended to permit redevelopment of property in circumstances in which a property, including its structures, site improvements and infrastructure, is suitable for reuse but the reuse is not consistent with the underlying zoning district, rezoning to another classification would permit other uses potentially detrimental to surrounding properties, and any potentially adverse effects of the intended reuse can be mitigated by conditions on the reuse.

Sec. 114-646. Permitted uses, conditional uses and other uses.

- (a) Uses in a flex development may at times not coincide with those anticipated within the underlying zoning district. However, uses in a flex development shall be compatible with existing, proposed and anticipated uses, and shall not be a detriment, a nuisance or injurious to other permitted uses or properties in the area.
- (b) Any permitted use and conditional use as permitted in the underlying zoning district is permitted in the flex development overlay district unless expressly prohibited by the use supplement.

- (c) Other uses may be permitted in accordance with those contained in the use supplement as developed by the chief building inspector, in consultation with the director of city development, and submitted to the plan commission and common council. A use supplement adopted by resolution of the common council shall list all those additional uses which, when applying good and reasonable judgment, are determined to not be detrimental to the subject, adjacent and area properties.
- (d) Minor and major changes to the use supplement shall be permitted as follows: minor changes may be approved by the chief building inspector but in consultation with the director of city development, and major changes shall require approval of the common council in accordance with sec. 114-648.

Sec. 114-647. Standards.

The plan commission shall not recommend approval of a use supplement and the permitted uses contained therein unless the plan commission finds that:

- (a) The establishment, maintenance, or operation of the uses will not be detrimental to or endanger the public health, safety, morals, comfort or general welfare;
- (b) The uses will not be injurious to the use and enjoyment of other property in the immediate vicinity for the purposes already permitted, nor substantially diminish and impair property values within the neighborhood;
- (c) The establishment of the uses will not impede the normal and orderly development and improvement of the surrounding property for uses permitted in the underlying district;
- (d) Adequate utilities, access roads, drainage and/or necessary facilities have been or are being provided;
- (e) Adequate measures have been or will be taken to provide ingress and egress so designed as to minimize traffic congestion in public streets;
- (f) The proposed uses will neither have an adverse impact nor set an undesirable precedence with relation to the objectives of the current land use plan for the area or the city;
- (g) Adequate conditions have been included in the use supplement that advance the goals of the preceding standards.

Sec. 114-648. Designation of the flex development overlay district.

- (a) Amendments to designate the flex development overlay district shall be accomplished in accordance with Article II, Division 4 of this chapter.
- (b) The recommended use supplement shall be presented at the time of the hearing before the plan commission for the flex development overlay amendment request and considered concurrently as the ordinance amendment proceeds."

Part 5:

This ordinance shall take effect upon passage and the day after publication.
