Presentation of the Tree City USA Award Guest: Kim Sebastian - DNR

Kim Sebastian, Forester with the Wisconsin Department of Natural Resources presented the 14th Tree City USA award to the City and City Forester, Matt Koepnick. Kim congratulated and thanked the city for putting their green foot forward and caring for trees in the community. To receive this award, four standards must be met on an annual bases. These include 1) having a tree board or department 2) tree ordinance(s) in place 3) spend \$2 per capita 4) hold a Arbor Day celebration and proclamation.

Update of tree planting and future plans Guest: Matt Koepnick, City Forester

Matt Koepnick, City Forester, discussed the recently concluded spring tree planting. A total of 773 trees were planted along the streets and in the parks. This had been the largest single tree planting since records were kept in 1974. A very large majority of the trees planted were bare root versus balled-and-burlapped. The forestry crew planted 493 of the trees, the remaining had been planted by a contractor.

The forestry crew has plans to plant 450 bare root trees this fall. The target will be arterial roads and tree planting requests.

Long term goals include establishing a formal tree planting policy and troubleshooting some potentially difficult areas. He discussed staffing needs. Planting 1,000+ trees per year results in an enoumous amount of planning. It also means the city's small forestry division has more trees to maintain.
