Subject: (Direct Referral) Communication from the Assistant Commissioner of Public Works/Operations wishing to discuss the 2010 extension of the Juror Parking Agreement with Racine County Clerk of Courts.

Recommendation: The 2010 extension of the Juror Parking Agreement with the Racine County Clerk of Courts be amended to allow juror parking at 2-hour parking meters on Wisconsin Avenue and College Avenue south of 7th Street during Racine County Courthouse construction, and be approved as amended. Further recommends that the Mayor and City Clerk be authorized and directed to execute the agreement on behalf of the City of Racine.

Fiscal Note: The agreement will generate \$6,840 for the Parking System.

Rose Lee appeared before the Commission and requested the agreement be amended to allow juror parking at the 2-hour meters on Wisconsin Avenue and College Avenue, south of 7th Street during the construction at the Court House.

Motion made by Craft, seconded by DeHahn to approve. Passed.

Uptown Improvement Organization Board of Directors, requesting the City of Racine consider constructing a stairway from the lower parking lot at 13th Street and Washington Avenue to Maiden Lane.

Recommendation (12/09/09): Defer

Tom Eeg commented there was no sidewalk on Maiden Lane, so it was not an ideal place to install a stairway. He indicated it would be better for the parkers to use the parking lot and existing sidewalks on 13th Street, but this doesn't address the lack of sidewalk on Maiden Lane.

Fiscal Note: N/A

Alderman Maack, on behalf of Gary Czechowicz, requested the bus stop located at the southwest corner of Goold and Geneva be moved to the southeast corner of that intersection.

Fiscal Note: This amendment will result in an annual contract increase of \$3,134.00 with funding available for this service.

When Mike Glasheen retired, the City was unsuccessful in filling the job. PTM came forward with handling the Transit Planner's duties. This would implement a wage increase to cover the additional duties currently being done by PTM. This would be a 2% increase, or \$3,134.00 for this contract.
