Snap Trends is an Intelligence-Led Policing and Situation Awareness platform. It allows law enforcement to data-mine open social media and networking transmissions. This allows officers access to information regarding homicides and other major crimes as well as real time data monitoring during major events such as 4th of July, Prom, and Fireworks to predict where problems may be occurring or developing.
