A final revision in FTA Grant WI-04-0037-00 is needed to include funding for transit center roof and masonry improvements, bus shelters, service building roof repairs, a required radio system upgrade, cameras and AVL equipment for paratransit vehicles and repair or replace needed shop equipment. The grant had previously been only to replace bus shelters and upgrade them with real time schedule information.
