The Drink 961 Martin Luther King Drive

On 06-01-06 officers were in the area of 961 Martin Luther King Drive at 2:42 am and observed several people exiting the bar's south door. Officers made observations before entering the bar which included 4 individuals seated at the bar. Three of these individuals were drinking liquor in a plastic cup, while the fourth was drinking a Miller Lite beer.

Officers made contact with the bar's owner, ANDREW RACLIN. After being advised that closing time is 2:00 a.m., RACLIN advised officers that he wasn't aware of what time bar closing was because he was from Illinois. RACLIN also told officers that the individuals inside the bar were all working for him, cleaning up. However, when the officers made their observations, there was only one person cleaning. RACLIN also claimed that TIM ANDERSON was the bouncer. However, according to the officer's report, he was highly intoxicated and could barely walk.

RACLIN was issued a UMCC for a closing hours violation, UMCC # N564786. Please see attached copy of UMCC and report from the responding officer.

There were no other noteworthy incidents during the month of June.

06/08/1997 Officers responded to a report of large fight at the establishment. As officers arrived, a number of people were fleeing the area. The three primary players in the fight were located and cited for disorderly conduct, underage on premises or possession/consumption by underage person. The bartender on duty was ALMA HINOJOSA. She was also cited for sale to underage persons.

08/02/1996 A complaint of an unwanted party brought officers to the address. Bartender, TEIMA NEAVE, requested an intoxicated male to leave the premises, but he would not leave. He left without incident when the officers asked him to move on.

07/01/1996 LICENSED TO: ALMA HINOJOSA

03/10/1996 Bartender ANTONIA MARQUEZ reported to responding officers that two male patrons in the tavern were having "some problems" and were arguing. The officers spoke with the two and learned that the argument stemmed over who was going to buy the next drink. Both were permitted to stay provided they did not cause any more problems.

06/27/1995 Antonia Marquez called before License and Welfare Committee.

06/17/1995 Bike patrol officers were flagged down about a fight in the street in the 900 block of King Drive. The bartender of the Marquez Club had just ejected an unwanted party and that individual had gotten involved in a fight in front of the tavern when he left.

02/11/1995 Officers responded in reference to a complaint of a fight within the bar. Upon Officers arrival, the primary aggressor had fled the area. However, a patron still within the tavern was identified by bar personnel as having been involved in this disturbance. Upon being interviewed by officers, this patron was observed to have an open laceration to his chin. However, this injured party refused any medical attention, and further indicated that he did not wish to pursue any charges against the individual who caused his injuries.

12/29/1994 Officers responded to a complaint of an unwanted patron who had been identified as being underage. Although refusing to leave the bar at the initial request of bar personnel, the unwanted party fled the area upon being notified that police had been contacted. Officers arrived to find no additional problems.

10/15/1994 Officers were dispatched to this location in regards to a complaint of a man with a gun in the parking lot. The on-duty personnel advised that an argument had erupted within the bar. However, the two males and one female involved all left the tavern without incident.

09/24/1994 Officers responded to this location in reference to a complaint of a stripper performing within this bar. Upon officers arrival, it was determined that a retirement party for a regular customer was taking place inside. Bar personnel stated that a dancer from the Wam Bam tele-gram service had performed within the tavern. However, the bartender stated that during the course of this performance, the doors to this establishment were locked. This establishment is not licensed for this type of entertainment to the public. However, it is the belief of the bartender that closing off the bar during the performance constituted a private party. This matter will be referred to the City

Attorney for review and recommendation.

- 09/11/1994 Officers responded to this location in reference to a complaint of a stabbing. Upon arrival, officers located a male patron of the bar lying outside on the ground. This subject was noted to be injured; however, not stabbed. Bar personnel acknowledge that a disturbance between two patrons had taken place within the tavern. The injured patron was transported to St. Mary's Hospital for treatment of an injury to his nose.
- 07/15/1994 Officers responded in reference to a complaint of a fight. Upon officers arrival, three males were observed to be arguing outside of the bar. Officers identified the parties involved in this disturbance. However, no one wished to pursue any charges or otherwise cooperate. A male patron involved in this disturbance was taken into custody on outstanding warrants. The arrest of this patron solved the problem for the evening.
- 07/10/1994 Officers responded after observing a large group of patrons gathering in front of this tavern. Officers subsequently located an unconscious party within the bar. It was established from parties within the area that the unconscious party had been assaulted. However, upon regaining consciousness, this patron stated that he did not wish to press charges against his attackers. The unconscious patron had produced a knife during this attack, and was, therefore, cited for being in possession of this weapon.
- 06/11/1994 Officers responded in regards to a complaint of an unwanted party. Upon officer's arrival, the on duty personnel (SANCHEZ) identified the unwanted patron who was still within the tavern. The unwanted patron left the bar at the request of officers.
- 11/13/1993 Officers responded reference to an unwanted party. On arrival, officers spoke with the bartender who pointed out a very intoxicated, passed out patron. The bartender stated they wanted the party removed because she was closing.
