Real Racine, on behalf of the event owner Upstate Watercraft Promotions, Inc, requests the use of North Beach on Saturday, July 13 through Sunday, July 14 for the Pro Watercross Tour. We would also like to use the volleyball courts on Sunday, July 14 for an EVP volleyball tournament to run in conjunction with Pro Watercross. There will not be any volleyball on Saturday, July 13.

Here is the specific event information:

Name of Event: Pro Watercross Racine Tour Stop & EVP Volleyball Tournament

Description of Event: Pro Watercross takes place on Lake Michigan and its shore. Pro Watercross includes professional jetski and watercraft athletes participating in both races and freestyle events. This event occurred at North Beach most recently last year on July 28-29, 2018. The EVP Volleyball Tournament is a single-day event and was played on Saturday, July 28, 2018. This year it is moving to Sunday.

Park Location: North Beach, Kids Cove Parking Lot, Volleyball Courts (Sunday only)

Date/Time: Saturday and Sunday, July 13-14, 2019 from 10am-4pm.

Schedule:

Truck and equipment trailer arrive late Thursday, July 11 to Kids Cove Parking Lot. Setup begins Friday July 12 around 9am and continues throughout the day. The beach can remain open throughout setup, event days and tear down. Pro Watercross begins at 10am on both Saturday and Sunday and continues until about 4pm. There will be a Rider Meeting at 8:30am both Saturday & Sunday on the beach. Tear down begins immediately after the last race and is complete by Sunday evening. Equipment truck will depart early Monday morning. EVP Tournament will use the volleyball courts from 8am-5pm on Sunday, July 14 (all setup, play and teardown within that timeframe.)

Parking: We are requesting use of the entire Kids Cove Parking Lot for equipment trucks & trailers. I would like to discuss additional parking rules and availability with PRCS before the event.
