Ordinance 0021-21 – Decennial Aldermanic District Boundary Modifications

An ordinance to amend Chapter 2, Article II, Division 2, of the Municipal Code of the City of Racine, Wisconsin.

Part 1: Chapter 2, Article II, Division 2, section 2-36, of the Municipal Code of the City of Racine, Wisconsin, is amended as follows:

By deleting the number "2012," and inserting the number "2022," therefor.

Part 2: Chapter 2, Article II, Division 2, section 2-37, of the Municipal Code of the City of Racine, Wisconsin, is repealed and recreated as follows:

2-37. – Aldermanic district number 1.

Aldermanic district number 1 shall be comprised of municipal ward numbers 1, 2, and 3.

(1) The first municipal ward shall contain all of the territory included within the following description:

(2) The second municipal ward shall contain all of the territory included within the following description:

centerline of the right-of-way for Eleventh Street for 1,790 feet to a point on the centerline of the right-of-way for Eleventh Street; thence southerly to the shoreline of Lake Michigan; thence following the Lake Michigan Shoreline easterly, then turning northerly along the shoreline of Lake Michigan to the centerline of the Root River; thence westerly along the centerline of the Root River to the centerline of the right-of-way for Marquette Street to the point of beginning.

(3) The third municipal ward shall contain all of the territory included within the following description:

Part 3: Chapter 2, Article II, Division 2, section 2-38, of the Municipal Code of the City of Racine, Wisconsin, is repealed and recreated as follows:

2-38. – Aldermanic district number 2.

Aldermanic district number 2 shall be comprised of municipal ward numbers 4 and 5.

thence southerly along the City of Racine Corporate Boundary, which is also the centerline of the right-of-way for Oregon Street, to a point where the boundary turns west; thence westerly along the City of Racine Corporate Boundary to a point where the boundary turns south; thence southerly along the City of Racine Corporate Boundary to a point where the boundary turns west; thence westerly along the City of Racine Corporate Boundary to a point, on the east right-of-way line for Meachem Road where the boundary turns north; thence northerly along the City of Racine Corporate Boundary, which is also the east right-of-way line for Meachem Road to a point where the boundary turns west; thence westerly along the City of Racine Corporate Boundary to a point where the boundary turns south; Beginning at a point at the intersection of the centerline of the right-of-way for Durand Avenue and the centerline of the right-of-way for South Green Bay Road; thence easterly along the centerline of the right-of-way for Durand Avenue to the centerline of the right-of-way for Illinois Street; thence northerly along the centerline of the right-of-way for Illinois Street to a point where the City of Racine Corporate Boundary turns east; thence easterly along the City of Racine Corporate Boundary to a point where the boundary turns north; thence northerly along the City of Racine Corporate Boundary to a point where the boundary turns east; thence easterly along the City of Racine Corporate Boundary to a point where it turns north, at Oregon Street; thence northerly along the City of Racine Corporate Boundary to a point where the boundary turns east, at Pierce Boulevard; thence easterly along the City of Racine Corporate Boundary to a point where the boundary turns south; thence along the City of Racine Corporate Boundary to a point where the boundary turns east; thence easterly along the City of Racine Corporate Boundary to a point where the boundary turns south; thence southerly along the City of Racine Corporate Boundary to the centerline of the right-of-way for Durand Avenue; thence east along the centerline of the right-ofway for Durand Avenue to the centerline of the right-of-way for Lathrop Avenue;

thence northerly along the centerline of the right-of-way for Lathrop Avenue to the centerline of the right-of-way for Twenty-first Street; thence easterly along the centerline of the right-of-way for Twenty-first Street to the centerline of the right-of-way for West Lawn Avenue; thence northerly along the centerline of the right-of-way for West Lawn Avenue to the centerline of the right-of-way for Twentieth Street; thence westerly along the centerline of the right-of-way for Twentieth Street to the centerline of the right-of-way for Lathrop Avenue; thence northerly along the centerline of the right-of-way for Lathrop Avenue to the centerline of the right-of-way for Seventeenth Street; thence westerly along the centerline of the right-of-way for Seventeenth Street to the centerline of the rightof-way for Ohio Street; thence southerly along the centerline of the right-of-way for Ohio Street to the southern boundary line of Parcel #22907000 extended; thence westerly along the southern boundary line of Parcel #22907000 extended to the City of Racine Corporate Boundary; thence continue westerly along the City of Racine Corporate Boundary to a point where the boundary turns north; thence northerly along the City of Racine Corporate Boundary to a point where the boundary turns west; thence westerly along the City of Racine Corporate Boundary to a point where the boundary turns north; thence northerly along the City of Racine Corporate Boundary to a point where the boundary turns west at Sixteenth Street; thence westerly along the City of Racine Corporate Boundary to a point where the boundary turns south; thence southerly along the City of Racine Corporate Boundary to a point where the boundary turns east; thence easterly along the City of Racine Corporate Boundary to a point where the boundary turns south; thence southerly along the City of Racine Corporate Boundary to a point where the boundary turns east; thence easterly along the City of Racine Corporate Boundary following the curve to a point where the boundary turns south; thence southerly along the City of Racine Corporate Boundary to a point where the boundary turns east; thence easterly along the City of Racine Corporate Boundary to the centerline of the right-of-way for South Green Bay Road; thence southerly along the centerline of the right-of-way for South Green Bay Road to the point of beginning.

Part 16: Chapter 2, Article II, Division 2, section 2-51, of the Municipal Code of the City of Racine, Wisconsin, is repealed and recreated as follows:

2-51. – Aldermanic district number 15.

Aldermanic district number 15 shall be comprised of municipal ward numbers 37 and 38.

(1) The thirty-seventh municipal ward shall contain all of the territory included within the following description:

Beginning at a point at the intersection of the centerline of the right-of-way for Douglas Avenue and the centerline of the right-of-way for Shoreland Drive; thence easterly along the centerline of the right-of-way for Shoreland Drive to the centerline of the right-of-way for Fourth Avenue; thence northerly along the

centerline of the right-of-way for of Fourth Avenue to the centerline of the rightof-way for North Street; thence easterly along the centerline of the right-of-way for of North Street to the centerline of the right-of-way for LaSalle Street; thence northerly along the centerline of the right-of-way for LaSalle Street to the centerline of the right-of-way for Carlton Drive; thence easterly along the centerline of the right-of-way for Carlton Drive to the centerline of the right-ofway for Monterey Drive; thence northerly along the centerline of the right-of-way for Monterey Drive to the centerline of the right-of-way for Montclair Drive; thence easterly along the centerline of the right-of-way for Montclair Drive to the centerline of the right-of-way for Green Street; thence northerly along the centerline of the right-of-way for Green Street to the centerline of the right-ofway for Three Mile Road; thence easterly along the centerline of the right-of-way for Three Mile Road to the centerline of the right-of-way for Erie Street; thence northerly along the centerline of the right-of-way for Erie Street to the City of Racine Corporate Boundary at Thunderbird Drive; thence westerly along the City of Racine Corporate Boundary to a point where the boundary turns south; then southerly along the City of Racine Corporate Boundary to a point where the boundary turns east; thence easterly along the City of Racine Corporate Boundary to a point where the boundary turns south; thence southerly along the City of Racine Corporate Boundary to a point where the boundary turns west at Three Mile Road; thence westerly along the City of Racine Corporate Boundary to a point where the boundary turns south; thence southerly along the City of Racine Corporate Boundary to a point where the boundary turns west; thence west along the City of Racine Corporate Boundary to the centerline of the right-of-way for the Chicago and Northwestern railroad right-of-way; thence southerly along the right-of-way for the Chicago and Northwestern railroad right-of-way to the centerline of the right-of-way for South Street; thence easterly along the centerline of the right-of-way for South Street to the centerline of the right-ofway for Douglas Avenue; thence northerly along the centerline of the right-ofway for Douglas Avenue to the point of beginning.

(2) The thirty-eighth municipal ward shall contain all of the territory included within the following description:

Beginning at a point at the intersection of the centerline of the right-of-way for Green Street and the centerline of the right-of-way for Three Mile Road; thence southerly along the centerline of the right-of-way for Montclair Drive; thence, westerly along the centerline of the right-of-way for Monterey Drive; thence southerly along the centerline of the right-of-way for Monterey Drive to the centerline of the right-of-way for Carlton Drive; thence westerly along the centerline of the right-of-way for Carlton Drive to the centerline of the right-of-way for LaSalle Street; thence southerly along the centerline of the right-of-way for LaSalle Street to the centerline of the right-of-way for North Street; thence, easterly along the centerline of the right-of-way for North Street to the City of Racine corporate boundary at Erie Street; thence northerly along the City of Racine corporate

boundary to a point where the corporate boundary turns east; thence easterly along the City of Racine Corporate boundary to a point where the corporate boundary turns north at North Main Street; thence northerly along the City of Racine corporate boundary to a point where the corporate boundary turns east; thence easterly along the City of Racine corporate boundary to a point where the corporate boundary turns south; thence southerly along the City of Racine corporate boundary to a point where the corporate boundary turns east; thence easterly along the City of Racine corporate boundary to a point where the corporate boundary turns north; thence northerly along the City of Racine corporate boundary to a point where the corporate boundary turns east; thence easterly along the City of Racine corporate boundary to the western shore of Lake Michigan; thence northerly along the western shore of Lake Michigan to the City of Racine corporate boundary; thence westerly along the City of Racine corporate boundary to a point where the corporate boundary turns north; thence northerly along the City of Racine corporate boundary to a point where the corporate boundary turns east; thence easterly along the City of Racine corporate boundary to a point where the corporate boundary turns north; thence northerly along the City of Racine corporate boundary to a point where the corporate boundary turns east; thence easterly along the City of Racine corporate boundary to a point where the corporate boundary turns north; thence northerly along the City of Racine corporate boundary to a point where the corporate boundary turns west; thence westerly along the City of Racine corporate boundary to the centerline of the right-of-way for Erie Street; thence southerly along the centerline of the right-ofway for Erie Street to the centerline of the right-of-way for Three Mile Road; thence westerly along the centerline of the right-of-way for Three Mile Road to the point of beginning;

Part 17: This ordinance shall take effect upon passage by a majority vote of the members-elect of the City of Racine Common Council and publication or posting as required by law.

Fiscal Note: N/A.

Pursuant to Wisconsin Statutes section 62.09(8)(c), the mayor shall have the veto power as to all acts of the common council, except such as to which it is expressly or by necessary implication otherwise provided. All such acts shall be submitted to the mayor by the clerk and shall be in force upon approval evidenced by the mayor's signature, or upon failing to approve or disapprove within 5 days, which fact shall be certified thereon by the clerk. If the mayor disapproves the mayor's objections shall be filed with the clerk, who shall present them to the council at its next meeting. A two–thirds vote of all the members of the council shall then make the act effective notwithstanding the objections of the mayor.
