Scott Letteney, Deputy City Attorney, and Brian O'Connell, Director of City Development, appeared before the Committee to discuss the item. Mr. Trones, does HVAC work, performed work for the City Development Department on two different occasions with the service considered low quality so he was removed from the certified bidders list. Regarding the 17 bids he claims he should have been awarded, the time required for submission is 120 days which he does not meet. Scott recommends the claim be denied.

Scott Letteney, Deputy City Attorney, Alderman Sandy Weidner and Brian O'Connell, Director of City Development, appeared before the Committee to discuss the item. The company is being investigated on an issue with a City employee who has left employment. There has been a significant concern by the City Development Department regarding their ability to perform their services appropriately, in a timely manner and good quality. Coupled with a variety of personal issues the City removed the company from the certified bidder's list. Scott recommends the City deny this claim.

Scott Letteney, Deputy City Attorney, and Brian O'Connell, Director of City Development, appeared before the Committee to discuss the item. Rubel Plumbing LLC claims his submission of 3 bids were not the lowest bidder, but his cost still lower than the individuals who submitted their bids and had change orders. Rubel Plumbing states specifications on the bids showed no change orders accepted. Scott reviewed the bids and did not find change orders not accepted. The two companies receiving the bids had change orders that were all for things that could not have been anticipated based upon changed circumstances. Rubel Plumbing is a limited liability company and the City has standards for insurance coverage. Scott recommends the City deny this claim.

The truck was facing southbound in a northbound lane. Ms. Dodge drove on the left side of the road. In doing so the claimant collided with the reversing dump truck. She was issued a citation for driving left to center and paid it. Scott recommends that this claim be denied.
