**Subject:** Communication from the Transit and Parking System Manager requesting the review of the 2015 Parking Utility Budget.

Recommendation of the Transit and Parking Commission on 10-22-14: That the Common Council approve as submitted.

Fiscal Note: No impact on tax levy.

Fiscal Note: 2015 City contribution of \$1.2 million.

No service cuts, but elimination of 2 maintenance positions and reduction in supervisory and clerical staff hours.

**Subject:** Communication from the Transit and Parking System Manager requesting a discussion of the notice of non-award for an FTA "Ladders of Opportunity" grant to purchase replacement paratransit small buses and request for Common Council authorization to apply for an FTA Section 5339 grant for the same purpose as an alternative.

**10-22-14:** That the Parking and Transit System Manager be authorized to move the previously approved funding to replace DART (Dial-A-Ride) small buses that have reached the end of their service life to apply for an FTA Section 5339 Capital grant.

**Fiscal Note:** Local share (20%) funding has been approved in a previous year CIP and the amount should be sufficient because of the elimination of the more expensive CNG option.

**10-22-14:** That the Mayor and City Clerk be authorized and directed to enter into a three-year contract with two single-year optional extensions with Two-Story Creative Services for the provision of marketing and advertising services for the BUS.

**Fiscal Note:** Funding is included in the BUS budget.

The agency will be paid based on work performed. Much of the budgeted marketing funds will be for actual media purchases and is partially funded by an 80% Congestion Mitigation Air Quality (CMAQ) Federal grant.
