#### Call To Order

The meeting was called to order at 6:10 p.m.

#### Approval of Minutes for the March 11, 2008 Meeting.

On a motion by Coe, seconded by DeHahn, the Committee approved the minutes as printed.

#### 1. <u>08-1804</u>

**Subject:** Communication from David Resop, 1940 Jay Eye See Avenue, submitting a petition to partially vacate the north-south alley bounded by Jay Eye See Avenue, Twentieth Street, Case Avenue and DeKoven Avenue.

**Recommendation:** Since public interest requires it, that the following parcel of land, more particularly described as follows, be and hereby is vacated and discontinued:

The north-south alley bounded by Dekoven Avenue, 20th Street, Jay Eye See Avenue and Case Avenue.

Further recommends that a preliminary resolution be introduced to the Common Council and referred to the City Plan Commission.

Fiscal Note: Not applicable.

Dave Resop appeared and noted he did not get 100% of the residents signature to vacate the alley. Rick suggested the item be sent to the Plan Commission for a partial vacation of the alley and he had no objections to that.

On a motion by Coe, seconded by DeHahn, the Committee approved the request and referred the item to the Plan Commission for vacation procedure.

**2**. <u>08-1828</u>

**Subject:** Communication from Porters of Racine requesting to install a sign in the NW corner of the Courthouse Plaza during construction.

**Recommendation:** That Porters of Racine be granted permission to install a temporary sign in the public right-of-way in the 300 block of 7th Street with the following stipulations:

- A. A hold harmless agreement be executed, in accordance with State Statute 66.0425, Privileges in Streets.
- B. A certificate of liability insurance be filed.
- C. Porters of Racine shall place said sign.
- D. Any damages caused to said sign shall be the responsibility of Porters of Racine.

**Fiscal Note:** There will be no cost to the City of Racine.

Micah Waters appeared and noted he wanted to install a sign during construction directing customers to Porters. Rick noted the City had no purview over County owned property. Rick noted Mr. Waters could install a sign in the public right-of-way directing customers to his business and a hold harmless agreement and liability insurance would have to be filed with the City. John suggested Mr. Waters contact the contractor to see if he could attach his sign to one of the contractors barricades as well. Rick asked the item be approved in case the contractor does not want to accommodate Mr. Waters.

On a motion by Coe, seconded by DeHahn, the Committee approved the request.

3. <u>08-1829</u>

**Subject:** Communication from the Sierra Club Southeast Gateway Group submitting a proposal for the use of rain barrels to reduce storm water runoff and municipal water usage.

**Recommendation:** The Commissioner of Public Works be authorized

and directed to purchase 200 rain barrels.

Further recommend that the Mayor and City Clerk be authorized and directed to enter into an agreement with the Southeast Gateway Group of the Sierra Club for distribution and installation of rain barrels for City of Racine Residents.

- 1. Rain Barrels will be made available only to City Residents at a cost of \$20.00 for the rain barrel and \$35.00 for delivery and installation.
- 2. Sierra Club will collect all fees and shall pay the City of Racine \$20.00 for each rain barrel which is distributed.
- 3. City of Racine and Sierra Club agree to jointly promote the project.

**Fiscal Note:** This program will provide rain barrels only to City of Racine residents. The estimated cost of the program is \$7,000.00 and is funded through the Storm Water Utility.

Rick read a letter from the Sierra Club wishing to use rain barrels to lower Total Suspended Solids and Stormwater Education. Rick noted the City could purchase and provide rain barrels for pickup by citizens. The Sierra Club would provide installation. There was a discussion between Jeff Sytsma and the Committee on the cost and installation charges. Rick noted this could be a co-operative agreement between the City and the Sierra Club and funding is available in the Stormwater Utility.

On a motion by Coe, seconded by DeHahn, the Committee approved the request. Recommended For Approval

**Subject:** Use of east end of Melvin Avenue extended for placement of an emergency generator and an underground electrical line in the public right of way on Michigan Boulevard

**Recommendation:** That the request to install an emergency generator at the terminus of Melvin Avenue at Lake Michigan be approved.

**Fiscal Note:** As a city owned utility, the Wastewater Utility does not require permission to place its infrastructure in the public right-of-way.

Keith Haas appeared and explained that the generator would be used as back-up power to a pump station to alleviate back-up of sanitary sewage along Michigan Boulevard. He distributed some photos of a location for the generator to be placed, which could be landscaped or a retaining wall in front of it to hide the facility from view. Keith and Rick both noted the size of the generator was probably no bigger than a traffic control cabinet for signal operations.

On a motion by Coe, seconded by DeHahn, the Committee approved the request.
