Steven Hill was present to discuss this request. Mr. Hill stated he has been with Speedway for approximately 2 months, and has worked in retail for about 16 years. There was a discussion regarding having at least one employee with an operators license on site at all times. Attorney Weber confirmed that it is a law to have at least one person with an operators license scheduled at all times. Mr. Hill added that Speedway has a policy where they do random underage checks at their locations. Mr. Hill terminated employees who aren't holding up the standards, worked on the appearance of the store, after 11:00 p.m. there is Bullet Resistant (BR) glass that comes down, and he is available from 5:00 a.m. to 4:00 p.m. Alderman Perez moved to approve Steven Hill as agent for Speedway, LLC, 4620 Washington Avenue. Alderman Kaprelian-Becker seconded the motion. Motion passed on a voice vote.

Mr. Bangert told the committee the last violation was in April of 2012, and has had no other violations since signing his side agreement. Mr. Alabed explained the Racine Police Department has implemented a new procedure that includes scanning items, he instituted training for all of his employees to check gold, scan the ID which records the time, and the counter where transactions occur is video taped and stored for up to 7 days. Alderman Shields was present and voiced support for the application. Alderman Kaprelian-Becker moved to approve the application for a Second Hand Jewelry Dealers License for Iyad Alabed, Sunshine Supermarket, along with a side agreement with sunset date signed by Mr. Alabed. Alderman Sarrazin seconded the motion. Alderman Perez opposed the vote. After further discussion, Alderman Perez requested to amend his vote to yes. Motion passed on a voice vote.
