Thursday 03/09/17

TBG's – 1814 Taylor Avenue – Civil Trouble (Assisted): Officers were called to the bar reference a missing pool cue. While the Police were there, the complainant located the missing pool cue and no report or further assistance was needed. No violations were observed inside the bar. **17-10659** Call Received: 4:46PM.

Friday 03/10/17

Blue Rock Lounge – 306 Sixth Street – Fight (Assisted): Officers were called to the bar because a physical altercation broke out between two male parties.
