Public Comments on a proposed amendment to the 2015-2019 Consolidated Plan for the City of Racine and creation of a Neighborhood Revitalization Strategy Area (NRSA).

### Approval of Minutes for the January 5, 2017 Meeting.

**<u>79-17</u> Subject:** (Direct Referral) Request by the Manager of Housing and Community Development for the reallocation of \$140,000 of CDBG funds from Housing Repair Loan Program 2015 Homeowner and Rental Match to purchase and rehabilitate a two-unit residential property at 1531 Packard Avenue.

*Staff Recommendation: That the request for the reallocation of 2015 funds be approved.* 

*Fiscal Note: There are sufficient CDBG funds available to meet this request. 2015 CDBG Homeowner and Rental Match funds will expire in June 2017. The program was allocated through Res. 15-0327.* 

**Subject:** (Direct Referral) Request by the Manager of Housing and Community Development for the allocation of up to \$250,000 of NSP 1 and NSP 3 funds to build a new single-family house at 1538 Packard Avenue and up to \$14,000 of HOME funds if NSP program income at the time of construction is not sufficient to cover budgeted construction contingency.
