Dear Mayor Mason and Common Council,

The 44th anniversary of the Lighthouse Run is scheduled for Saturday, June 25, 2022 beginning at 7:45 a.m. at 725 Lake Avenue in Racine. We request the City's support of the race and post race activities.

In previous years, the City and departments helped make the race a huge success. We require the cooperation of Public Works, Police, Fire, Transit and others. Route maps are also attached:

**Street Requirements:**

- 725 Lake Avenue North to State Street
- Main Street from State Street to 4 Mile Road (west side two traffic lanes will remain open for two-way traffic), and to 5<sup>th</sup> Street/Monument Square for returning participants. 10 Milers run to 3 Mile Road and head East to Lighthouse Drive Northeast to 4 Mile Road, returning downtown south on North Main Street
- Dodge Street from Main Street to Michigan Blvd.
- Michigan Blvd from Dodge Street to Lakecrest Ave
- Lakecrest Avenue to North Main Street
- Kewaunee Street from Michigan Blvd. to North Main Street
- Wolff Street from Michigan Blvd. to North Main Street.
- Hamilton Street from Main Street to Michigan Boulevard
- 3 Mile Road to Lighthouse Drive
- Lighthouse Drive to 4 Mile Road
- 4 Mile Road to North Main Street

The finish line will again be on Main Street and we have requested the use of Monument Square and Sam Johnson Parkway from Parks, Recreation & Cultural Services. As an overview – we will plan to have amplified music on Sam Johnson Causeway from 9:00 a.m. until 11:30 a.m. (this time also includes the awards ceremony). We will have amplified announcements at 725 Lake Avenue from 7:00 a.m., moving to Monument Square placed at 5th and Main from until 10:30 a.m. – these announcements will be runner information and incoming runners. We will be serving beer and/or wine to the participants from approximately 9:00 a.m. until 11:30am at the top of Sam Johnson Causeway.
