Staff Recommendation to the Public Works and Services Committee on 05-31-22: That permission be granted to the YMCA to use certain City streets for a period of 6:00 a.m. - 12:00 p.m. on Saturday, June 25, 2022, and close the following streets:.

FULL CLOSURES

Lake Avenue from Eighth Street to State Street / Gas Light Drive State Street / Gas Light Drive to Main Street Main Street between Sixth Street and State Street Intersection of State and Main Streets

Sixth Street between Main Street and Wisconsin Avenue (if full closure not possible for the duration of the event, between 9:30-10:30am would be requested)

Dodge Street between Michigan Boulevard and Main Street

Kewaunee Street between Michigan Boulevard and Main Street Wolff Street between Michigan Boulevard and Main Street

Michigan Boulevard between Dodge Street to Kewaunee Street

PARTIAL CLOSURES

North Main Street from State Street to 3 Mile Road (east lane open) 3 Mile Road from N. Main Street to Lighthouse Dr. (southern half of 3 mile) Michigan Boulevard from Kewaunee Street to Wolff Street (east lane open)

Further recommends that the Commissioner of Public Works be authorized and directed to communicate with the U.S. Coast Guard requesting permission to close Main Street Bridge to boat traffic for a period of 7:40 a.m. to 11:00 a.m. on Saturday, June 25, 2022, to satisfy the needs of this run.

Further recommends that this permission is granted with the following stipulations:

- A. A hold harmless agreement be executed and a \$75.00 processing fee paid.
- B. A liability insurance certificate be filed prior to this event.
- C. Any overtime costs incurred by any City department be charged to the sponsor.
- D. The sponsor shall notify all abutting property owners 72 hours in advance of this event.
- E. The sponsor shall pay a \$1525.00 special event fee.
- F. If required, sponsor shall be responsible for submitting a Temporary Traffic Control Plan to the Engineering Department for approval and providing and removing all temporary traffic control devices and detour signs.
- G. If required, sponsor shall provide a detour plan for the closure of all State connecting highways, arterial and collector streets to the City Engineer for approval.
- H. If required, sponsor is responsible for cleaning the streets.
- I. If required, sponsor shall install parking meter hoods or temporary parking signs at least 24 hours in advance of the event and if this is not done, sponsor is responsible for vehicle towing and parking violation expenses of the violators.

Further recommends that the Commissioner of Public Works, City Engineer and Chief of Police provide limited assistance, in the interest of public safety, to implement this event.

Fiscal Note: There will be nominal costs to various City Departments, on a regular basis, to assist in implementing this event.
