Re: Amendment to Chapter 94 of the Municipal Code. – Parking Regulations.

On behalf of Chairperson Alder Jones, DPW Staff recommends the proposed amendment to the City of Racine Municipal Code Chapter 94 Article III – Parking Regulations. More specifically Section 94-141 – No Parking Zones, Schedule F:

We would like to DELETE the following item from section (1) No parking at any time:

- Wisconsin Avenue, west side, from Fifth Street south 35 feet.
- 18th Street, north side, from Mead Street to Howe Street.

We would like to EDIT the following item from section (1) No parking at any time:

- (from) Wisconsin Avenue, west side, from Sixth Street north 150 feet.
- (to) Wisconsin Avenue, west side, from Sixth Street north 360 feet.

We would like to ADD the following items to section (1) No parking at any time:

- Barker Street, both sides, from 600 feet east of Michigan Boulevard to east terminus.
- North Main Street, west side, from Melvin Ave. to South Creek Rd.

We would like to ADD the following items to section (46) No parking, loading zone from 7:00 a.m. to 4:00 p.m.:

Wisconsin Avenue, east side, from 184 feet south of Fifth Street thence south 50 feet.

Additionally in Section 94-143 – Limited Parking Zones, Schedule G:

We would like to DELETE the following item from section (2) One-half hour parking at any time:

• Barker Street, east terminus.

We would like to EDIT the following item from section (2) One-half hour parking at any time:

- (from) Barker Street, north side, from east terminus west 240 feet.
- (to) Barker Street, north side, from Hoffert Drive east 200 feet.

Please note that if committee and council agree:

- The Wisconsin Ave. requests are in conjunction with the Two Way Conversion of Wisconsin Avenue Construction Project, and can take effect immediately
- The 18<sup>th</sup> Street location can take effect as soon as city forces removes planters and add signage and pavement markings.
- The Barker Street is a request of the Racine Fire Department and can take effect immediately.
- The N. Main Street is in conjunction with the Main Street resurfacing project and can take effect when construction has been completed in that area.

There is no fiscal obligation for the City to amend the Municipal Code.

If the Committee agrees, the appropriate action would be to approve the amendment to the Municipal Code as described.
