Saturday, July 9, 2022

Taste of Soul Bar and Grill - 501 Sixth St - Noise Violation - Caller (Mike in the upper unit) reported loud music from the bar. Police arrived and advised the bar of the complaint. Call Received 12:43 AM **22-027739**

Sunday, July 10, 2022

Police arrived and were told the man had left but gave a description. Other officers doing an area check did locate a male matching the description and stopped him. The man became extremely uncooperative and aggressive. He kicked at police and spit on them. He was detained and an 8 inch long knife and a utility knife were located on him, but no gun. Joeys on Taylor - 1863 Taylor Ave - Man With A Gun - Caller (neighbor) reported a male went to his car and retrieved a gun. The man then held the gun up and began to walk back to the bar. Several people outside of the bar intervened and stopped the man from going into the bar. Police arrived and were told the man left prior to their arrival. Unknown what the issue was about. Joeys on Taylor - 1863 Taylor Ave - Suspicious Circumstances - The hospital called to report a male had come into the ER to get medical attention for a stab wound that had occurred at or near the bar. Police arrived at the hospital and spoke with the victim who claimed there was a fight outside the bar with two males he did not know. He tried to break up the fight and in doing so, was accidentally stabbed on the arm. Police then went to the bar and spoke with bartenders. They did admit there was a fight in the bar earlier (possibly related to 22-31647) but all parties had been made to leave out of a side door. Cameras did not capture the fight outside of the stabbing and unknown who the suspects were. Bar did not call for either incident. Call Received 12:55 AM	22-031653
Top Ten - 1301 Washington Ave - Suspicious Circumstances - A patron called twice, first reporting he had lost his ankle monitor during a fight and hung up. Dispatch could not get a hold of him on call back. The same number called again and the male said he was about to get shot. Police arrived and did locate the male who had been intoxicated. Two Sheets To The Wind - 3316 Douglas Ave - Man With A Gun - A patron called to report people had just pointed a gun at him. Police arrived and located the caller who had also tried walking away from police. As the caller walked away, he threw a bag of drugs on the ground. The caller said some men came into the bar and began to yell at him and took his girlfriends keys. He then said he was chased out of the bar, around the area and a gun was pointed at him. Police were able to talk with the bartender who said the caller and another male were outside and in a heated argument. She did not see a gun being pointed or anyone chasing anyone.
