Treatment Plant Biogas Conditioning System Design Services

Recommendation: Approve

The Wastewater Utility Director presented the proposal for the Plant Biogas Conditioning System design services. Biogas conditioning will aid in the performance of the new engines, and for meeting strict air permit regulations. The cost of this

proposal is \$205,400.00.

<u>0597-22</u> **Subject:** Request to Submit a Grant Application to Focus on Energy for

Plant Upgrade Projects

Recommendation: Approve

The Wastewater Utility Director discussed the plant upgrade, including a new UV

disinfection system, and new engines/blowers that will provide energy efficiencies that may be eligible for FOE grant monies. Permission was requested to apply. A project is eligible for matching funds up to \$300,000.00.

<u>0604-22</u> **Subject:** Wastewater Commission Directors Liability Insurance Policy Renewal

Recommendation: Approve

The Wastewater Utility Director presented policy renewal proposal provided by Atlantic Specialty Insurance Co. at a cost of \$16,960.00 (plus \$200 service fee). The policy would provide \$1,000,000.00 officer liability and \$1,000,000.00 employment practices liability insurance for the Commission body.

Subject: Request from the City of Racine to Approve its Peak Flow Mitigation Plan to Address Peak Flow Capacity Allocation Exceedances (Rusty Schroedel from AECOM, invited to meeting)

Recommendation: Defer

Ashley Leisgang from AECOM presented information regarding Racine peak hour flow capacity exceedances above 95% plant capacity resulting in sewer moratorium based on the 5/17/20 historical maximum storm. Per the Sewer Agreement, a SSR party must present a peak flow mitigation plan for consideration by the Wastewater Commission to remove a sewer moratorium. The Agreement provides that the Commission deem the plan to provide reasonable assurance that peak flows will be maintained within capacity compliance. The Commission granted Racine a 6-month temporary moratorium relief on 2/16/21 to better define its plan. The Commission granted Racine a 12-month temporary moratorium relief extension on 8/17/21 to allow the City and Utility to study a potential project collaboration in the Main-Goold sewer basin area. Brown and Caldwell completed the Main-Goold study on 3/16/22; however, the ensuing cost-of-service study (COSS) provided little capacity gain for Racine at the location of capacity exceedance (at the plant). The Agreement requirement that a SSR party show reasonable assurance to the Commission to approve a peak flow mitigation plan is open to interpretation. Peak flow reduction could be credited by a project providing an increase in capacity, but also possibly by inflow/infiltration (I/I) projects with the intent to reduce wet weather flow so additional capacity is not needed. These uncertainties impact a potential project at Main-Goold for Racine in terms of application to its mitigation plan. Thus, AECOM on behalf of Racine, requests a 60-day extension to address how peak flow credits are determined to better define its mitigation plan.

A motion was made by Lui, seconded by Mayor Mason, that this file be Deferred
