Marci's On Main - 236 Main St - Fight/Informational Report- A named complainant (Nurse) called from Freodtert Pleasant Prairie about an individual who was assaulted (head injury). It was learned the victim who did not wish to press charges was at Marci's on Main when a fight occurred inside the bar. The unknown victim stated they were struck with a bottle during the fight by an unknown party. It should be noted a call for a fight was received by police in the area of Third Street and Main Street (23-007083). When police arrived no active fight was observed and no one wished to speak with police.

Duo Bar and Grill - 1120 Mound Ave - Fight- Officers were in the area when they observed a large amount of people coming from the front entrance of the tavern yelling and appeared to be fighting. Officers were unable to locate the problem parties due to the large crowd outside the bar, which forced officers to deal with them and not the parties' involved in the fight. Officers made contact with an employee who stated a fight occurred inside the bar and the problem parties were pushed outside. Officers stayed on scene until the outside crowd began to disperse. Officers did check inside the bar and did not find any problems.

The Fifteen Eighteen -1518 Washington Ave- A Sergeant self-initiated a call for service to provide extra attention to the business. The Sergeant noted music could be heard coming from the tavern and approximately 2 dozen cars were still in the lot. It should be noted three people did attempt to enter the tavern but the door to the tavern was never opened and the parties left the area.

Upon recall the bartender answered and stated police were not needed and she was closing the bar for the night. Police were not dispatched to this call and it was closed out.

The Brickhouse - 316 Main St - Fight- An unnamed complainant called about a fight in the middle of the street in the 300blk of Main St. Upon officers arrival they did not locate an active fight in the area. The parties fighting inside the tavern were escorted out of the bar and continued to fight into the street. At this time without a victim or a way to identify the parties involved in the fight the case is closed.

Officers located a scene just to the south of the rear door of the tavern consisting of multiple fired casings. In addition a vehicle and a building to the east of the tavern were also struck by gun fire. No victims were reported for the shooting.
