1. Communication from the Commissioner of Public Works, submitting Amendment No. 3 from the Wisconsin Department of Transportation for the Main Street Bridge replacement project, I.D. 2350-03-02, Main Street Bridge and Approaches, STH 32, Racine County; (direct referral)

Recommends that Amendment Three to State Project No. 2350-03-02, STH 32, Main Street Root River Bridge, PE/Final Design B-51-0645, be approved as submitted, in the not-to-exceed amount of \$10,000.00, which is to be shared with the State on a 90% State/10% City participation.

Further recommends that funds in the amount of \$1,000.00, to defray the cost of these additional design services, be appropriated from Account 910-38-0-595, Main Street Bridge Engineering.

FISCAL NOTE: The cost to the City of Racine to implement Amendment Three is not to exceed \$1,000.00, and funds are available as herein delineated.
