SUBJECT: Request to Waive Formal Bidding Procedures and Contract with Safe Step

LLC for Sidewalk Inspection Services and "Angled Saw-Cutting" of

Sidewalk Vertical Displacements

Request that formal bidding procedures to be waived and the City be authorized to contract with Safe Step LLC, a franchisee of Precision Concrete Cutting, to visually inspect portions of the city's sidewalk system to identify trip hazards as well as sections of sidewalk that should be removed/replaced or "mud-jacked", and for the abatement of specific trip hazards on sidewalks via a proprietary "angled saw-cutting" technique using the price structure agreed to in Contract 20160056.

The 2017 – 2026 Ten Year Capital Improvement Plan includes \$400,000 in General Obligation Bond Debt funding in 2017 for sidewalk repairs and replacements in the right-of-way, continuing the sidewalk maintenance system instituted in 2016. Safe Step's services were integral to this program's initial success, and their letter of January 30, 2017, attached as Enclosure (1), extends the 2016 contract price structure for 2017.

Resolution 0112-16 waived formal bidding procedures and authorized the City to contract with Safe Step in 2016 to inspect sidewalks, provide proprietary angled-saw cutting of vertical displacements where appropriate, and draft scopes-of-work for sidewalk replacement and mudjacking contracts. Safe Step's proprietary angled saw cutting equipment and operating procedures produced repairs that are performing as well as new concrete at 35% to 50% of the cost of removal/replacement. No other contractor can replicate the quality of their angled saw-cutting system. Patent information, description of their proprietary process, and copies of sole source authorizations from the U.S. Department of Housing and Urban Development and various municipal governments are attached as Enclosure (2).

Fiscal Note: The estimated cost of this service will not exceed \$200,000, and funding is available in the 2017 - 2026 Capital Improvement Plan, Account 45040 57515 Dpw-Sidewalks.

Precision Concrete Cutting (PCC) is the Nation's Leading trip hazard removal company. Over the last 10-15 years PCC has developed and patented certain equipment and processes that are unique and proprietary to PCC. These patents have been successfully defended in court and many cities, universities and institutions have used PCC's Sole Source letter to conduct business with PCC to utilize its unique results that cannot be produced by other contractors or methods.

BACKGROUND:

Over time concrete sidewalks have a tendency to shift and settle creating offsets between concrete panels. In order to minimize trip hazards in the public right of way concrete cutting is used to flatten the offsets in the concrete walks. Precision Concrete has performed an assessment of the concrete offsets along the length of Magnolia Avenue and has provided a proposal to perform concrete cutting to remove the offsets and assess the balance of the Concrete walks throughout the City for an amount not to exceed \$58,000.

FISCAL IMPACT:

Funds for this work are included in the FY2013-2014 budget for ADA improvements.

STAFF RECOMMENDATION:

Staff recommends that Council authorize the City Manager to execute the Construction Services Agreement for removal of sidewalk offsets and to perform a sidewalk inspection for an amount not to exceed \$58,000.

ISSUE: Consideration of a Resolution authorizing a sole source contract with Precision Concrete Cutting (PCC) in an amount not to exceed \$25,000.

RECOMMENDATION: Adopt resolution.

BACKGROUND: On September 6, 2011, the City Council approved a Sidewalk Repair Program breaking the City into four Sectors and approving a multistep abatement plan as

follows:

Sidewalks within a Sector will be inspected by a qualified inspection contractor a. and trip hazards of less than 1.75-inches in height will be repaired at City cost.

The inspection contractor will provide written itemization of trip hazards greater b. than 1.75-inches in height within the Sector for future abatement.

Public Works will notice property owners who have trip hazards that exceed 1.75-C. inches in height of their responsibility to abate the trip hazard with an offer to cost share the abatement on a 50/50 split.

d. Property owners have the option of: (a) Performing the sidewalk repair themselves and not participating in the 50/50 cost-share; (b) Selecting their own contractor to perform the repair and submitting the invoice for a 50/50 cost-share reimbursement; or (c) Partnering with a larger aggregated City sidewalk repair contract and paying their split of the costs. In all cases a City encroachment permit is required with a recommended zero dollar fee if the property owner causes the work to be completed.

If the noticed abutting property owner does not choose to repair the trip hazard, e. then the City Public Works Department, as obliged under the Streets and Highway Code will make the repair and charge all costs as a lien on the property.

 <u>DISCUSSION:</u> Grinding concrete produces a variety of quality of final finishes depending on the level of effort expended and the experience of the contractor. As such, it is difficult to develop a specification for a "finished product" and accept as "complete" a publicly bid sidewalk grinding project. In light of this, staff has previously recommended that the City abate minor trip hazards utilizing a proprietary "angled saw cutting" technique. This resulted in a cleaner and neater repair that can be accurately sloped to meet ADA standards, has a reliable standard of quality, and can be measured for payment.

With the City's improved financial condition we are in a position to move forward with Phase II of the sidewalk repair program this summer and fall. Given the success of the previous "angled saw-cutting" staff is recommending that the Council approve a sole source contract with Precision Concrete Cutting (PCC), the contractor who performed similar work for the City in Sector A in 2011. PCC has satisfactorily performed this service for over 30 Bay Area cities, including Santa Rosa, Rohnert Park, Healdsburg and American Canyon.

 Under the Uniform Construction Cost Accounting Procedures, and PCC's proprietary methods, the City can sole source services up to \$35,000 annually. We requested a proposal from PCC for abatement of minor trip hazards and staff has determined that the proposal from PCC for "angled saw cutting" at \$30 per inch-foot (an "inch-foot" is equivalent to repairing a 1-inch high and 1-foot long trip hazard) is reasonable and PCC is qualified to perform the desired work.

Staff recommends that the Council adopt a resolution authorizing the City Manager to execute a sole source agreement with PCC in an amount not to exceed \$25,000 for inspection and "angled saw cutting" of trip hazards in "Sector B" and refreshing "Sector A".

<u>CONSISTENCY WITH CITY COUNCIL GOALS AND OBJECTIVES:</u> The recommended action supports the FY 2014/15 City Council Goal 3: Establish, improve and maintain City infrastructure; Objective No. 3 "Provide for long term maintenance and repair of City sidewalks."

FISCAL IMPACT: The FY 14/15 CIP adopted budget includes \$115,000 for sidewalk trip hazard repair, Account Number 01-5530-4915. The recommended resolution allocates \$25,000 to abatement of minor trip hazards in Sector B and refreshing of Sector A. \$90,000 is available for abatement of more extensive sidewalk repairs in Sector A which would be completed under a separate contract. As previously approved, these repairs are envisioned to be completed under a 50/50 cost-share with abutting property owners.
