<u>John Rooney</u> – Stated if the curb and gutter are in good shape, we leave it. If there are numerous curb and gutters on that road that need to be replaced, all will be replaced. If there is an existing driveway, the curb will be cut to create an apron. If there is not an existing driveway, and a homeowner wants to install a driveway, we will put in the curb cut and apron.

<u>Goran Markovic (2404 Webster Street)</u> – For PCCP. Wants to know if the construction will include his sidewalk, because a tree the Parks Department removed has destroyed his sidewalk.

Mark Yehlen – Explained new sidewalk program and said the sidewalk will get done when the stump that remains gets ground down.

<u>John Rooney</u> – Stated if the tree is still standing, the City will rip it out. When construction is completed it will be replaced with a smaller type of tree that will not rip up sidewalks with its roots.

<u>Fred Peterson (2401 Eaton Lane)</u> – Opposed, but if approved wants BCP. Owns Carlson Roofing. They have been there 15 years and do not feel the road is in that bad of condition. Most damage is not from traffic, but from utilities digging the road up. When the time does come to install a new road, his business will still need to access the yard to get trucks in and out.

<u>James Spangenberg (3324 Foxwood Road)</u> – Opposed, but if approved wants BCP. Owns a furniture warehouse on this block at 2811 & 2817 Eaton Lane. His building is the last one on this dead-end block. If the construction is approved, he will not have a way to get to his buildings and get the furniture delivered to customers other than going through the airport. He believes this will put him out of business.

<u>John Rooney</u> – Bituminous would be much faster for construction time. Traffic would be let through for most of the project, having total shut down only for a few sections of the project. If approved, we would work with all property owners and plan different routes for access. We will even have special stakeholder meetings with the property owners and maybe obtain special easements from the airport to grant access.
