Housing Tax Credit to help pay rent. The complainant is happy with the outcome.

Fair Housing Update:

- Staff is continuing to work with the Housing Authority on the AFFH process. Staff has three community meetings scheduled:
  - o May 9, 2018 at George Brae Center
  - o July 25, 2018 in Burlington, place to be determined
  - October 10, 2018 at Levi Barnes Apartments in Waterford, WI.

Staff will also be hosting smaller targeted meetings to reach specific populations or service providers. All meetings will be scheduled throughout 2018.

• The City of Racine will be participating in a Landlord Rights and Responsibilities Session on April 21, 2018 at Gateway Technical College from 8:00am – 2:00pm. The Tenant Rights and Responsibilities Session will be on May 12, 2018 at Knapp School from 9:00am-1:30pm.

#### Landlord Tenant Case:

• Complainant had a leak in the water pipe in the shower and received a \$900 water bill. The landlord had been made aware of the situation multiple times by the tenant and has not done anything. The leak is causing the walls to warp and mold to grow. The case was referred to the Environmental Health Department and the Building Department. Complainant cannot pay the \$900 water bill and landlord is threatening to evict here if she does not pay, staff referred this case to Legal Action Wisconsin.
