

Scott Henkel, Registered Land Surveyor, do hereby certify that I have prepared this Certified Survey Map at the direction of the Owner, The Redevelopment Authority for the City of Racine; that such CSM is a correct representation of all the boundaries of the land surveyed and is described as:

That part of the NE 1/4, SE 1/4, SW 1/4 and the NW 1/4, of the Northeast 1/4 of Section 20, Township 3 North, Range 23 East, in the City of Racine, County of Racine, State of Wisconsin, more particularly described as:

Commencing at the southwest corner of the Northeast 1/4 of Section 20, Township 3 North, Range 23 East;

Thence North 01°49'32" West, 1360.33 feet along the west line of said Northeast 1/4 Section to the north line of Dekoven Avenue;

Thence South 65°39'06" East, 290.22 feet along said north line; Thence North 88°00'22" East, 895.72 feet along said north line to the centerline of vacated Phillips Avenue and the point of beginning of this description;

Thence North 01°50'17" West, 891.79 feet along said centerline to the south line, extended, of Chicago Milwaukee and St. Paul Railway Company right-of-way;

Thence North 81°47'31" East, 30.19 feet along said south right-of-way line, extended, to the east line of Phillips Avenue;

Thence North 01°50'17" West, 50.31 feet along said east line to the north line of the south 1/2 of said right-of way;

Thence North 81°47'31" East, 549.25 feet along said north line to the west line of South Memorial Drive;

Thence South 02°18'26" East, 656.99 feet along said west line to the east line of a vacated parcel of Hamilton Avenue as recorded in Document No. 2007055 in the Office of the Register of Deeds of Racine County;

Thence along said east line being the arc of a curve bearing to the left 178.73 feet having a chord bearing and distance of South 14°12'54" East, 177.45 feet and a radius of 430.00 feet;
