#### **SUBJECT:**

A request by Kim – Eun Kyung Youn of Asiana Restaurant (Sara Vego – agent) appealing an approval of the Downtown Area Design Review Commission of an externally illuminated projecting sign at  $423 - 6^{th}$  Street.

#### **EXECUTIVE SUMMARY:**

The applicant wishes to appeal a decision of the Downtown Area Design Review Commission of June 6, 2018 approving a projecting sign for  $423 - 6^{th}$  Street subject to the sign being externally illuminated. Ms. Eun Kyung Youn wished to have an internally illuminated sign. Decisions of the DADRC are appealable to the Plan Commission and Common Council [114-828(h)].

#### **BACKGROUND & ANALYSIS:**

## Authority for the decision of the Downtown Area Design Review Commission

Since 1999 all permanent signage in the Downtown Design Review Area has required review and approval by Downtown Area Design Review Commission (DADRC) [Sec. 114-826(a)(2)]. The foundations for this authority stem from the following documents:


- 1988 designation by the US Secretary of the Interior of the building at 423 6<sup>th</sup> Street as a contributing (significant) building in the Historic Sixth Street Business District National Register Historic District;
- Common Council adopted 1999 Downtown Racine Development Plan from which the Downtown Area Design Review Commission (DADRC) was formed to ensure quality development in the Downtown area;
- Common Council adoption of the 2005 plan update titled the Racine Downtown Plan, Design Guidelines (the Plan, Pages 43 & 48);
- Zoning Ordinance Sec. 114-1080(4)(b) Signs, Prohibitions.

On June 7, 2018, through the authority described above, the DADRC approved a projecting sign for the business at  $423 - 6^{th}$  Street subject to the sign being externally illuminated. The applicant wishes to appeal the DADRC decision of June 7, 2018 and be allowed to install an internally illuminated projecting sign.

#### The Design

The proposed design illustrates a projecting sign that will be internally illuminated. The Downtown Design guidelines, the zoning ordinance, the historic designation of the building, and established standards of the DADRC dictate that the sign should be externally illuminated to maintain signage that is consistent and accurate to the historic character of the building and the National Register Historic District in which it is located.


