(Direct Referral) Communication from City Development, Housing and Community Development requesting \$1,139,032 for the 2018 Community Development Block Grant (CDBG) Public Services, Economic Development, and Public Infrastructure funding. (Res. 0186-18)

EXECUTIVE SUMMARY:

Department of City Development – Division of Housing and Community Development requests that the Community Development Committee review 2018 CDBG applications and funding recommendations.

BACKGROUND & ANALYSIS:

CDBG funds are available for Public Services, Public Facilities and Infrastructure, Economic Development, and Community-Based Development Organization (CBDO) Job Training activities.

The 2018 Annual Action Plan was approved by the Community Development Committee on May 24, 2018 and has been approved by the Common Council on June 5, 2018. Funding in the 2018 Annual Action Plan allocates CDBG funding that is available to eligible organizations.

A Notice of Funding Availability (NOFA) for CDBG was released on June 6, 2018 and application materials were due to the Department of City Development on June 29, 2018. CDBG funding is competitive and open to all qualified organizations.

City Development staff have received a total of 12 applications, including eight (8) applications for Public Services funding, two (2) applications for public facilities funding, one (1) application for Economic Development, and one (1) application for CBDO Job Training Activities. Department of City Development Staff have also reviewed the proposed allocation to ensure the funding is within HUD regulations.

In keeping with the Community Development Committee's established precedent, all applicant organizations have been invited to speak for up to three minutes and distribute written materials to committee members at the beginning of the meeting and before the allocation vote.

BUDGETARY IMPACT:


This action allocates \$1,139,092 of Community Development Block Grant funds per the 2018 Annual Action Plan. Sufficient funding exists to incur the budgeted expenses.

RECOMMENDED ACTION:

To allocate CDBG funds to organizations as indicated by staff, and that the Mayor and City Clerk be authorized to enter into contracts with the organizations pursuant to the funding allocation and federal regulations.
