Please be informed that the Public Safety and Licensing Committee of the Common Council of the City of Racine will meet at 5:30 P.M. in City Hall, Room 307, on Tuesday, February 12th, 2019, pursuant to the formal expression of concern issued on January 22nd, 2019.

It is requested that you appear at this meeting to discuss a Formal Expression of Concern under Section 6-27 of the City of Racine Ordinances, regarding being open and operating despite not having an occupancy permit at the licensed premises, along with other recent problematic incidents at the licensed premises.

Please be advised that the Committee will not ask for a discussion of the alleged facts unless you request such discussion. You are hereby advised that any statements made by you and/or your representatives regarding the alleged underlying facts may be considered by the due process board in any subsequent suspension/revocation hearing which may result from the alleged violations which are the subject of the formal expression of concern.

Any licensee who has been issued two formal expression of concern within a six month period, or three or more formal expressions of concern within a one year period, shall be referred to the city attorney's office for consideration of further disciplinary proceedings as contemplated under section 6-26 of this code. Such disciplinary proceedings including but are not limited to suspension and/or revocation of your license.

Sec. 6-27. - Actions by the committee.

- (a) Formal expression of concern.
 - (1) The public safety and licensing committee may require the appearance of any licensee before the committee at any time to address issues related to the licensed premises through a written formal expression of concern, sent via first class mail to the licensee.
 - (2) If the licensee fails to appear for the formal expression of concern, the committee may refer the matter to the city attorney's office for consideration of further disciplinary action.
 - (3) If the licensee appears for the formal expression of concern, no discussion of the alleged facts may be permitted unless the licensee requests such discussion and only after the licensee has been advised that any statements made by him or her and/or his or her representatives regarding the alleged underlying facts may be considered by the due process board in any subsequent suspension/revocation hearing which may result from the alleged violations which are the subject of the formal expression of concern.
- (b) Referral for disciplinary proceedings.
 - (1) Any licensee who has been issued two formal expressions of concern within a six month period, or three or more formal expressions of concern within a one year period, shall be referred to the city attorney's office for consideration of further disciplinary proceedings as contemplated under section 6-26 of this Code. For purposes of this section, the date the committee votes to issue a formal expression of concern shall be the date used to calculate any time period prescribed.
 - (2) Nothing in this section shall be construed to conflict with, abridge or modify, the rights or procedures established for revocation or suspension of licenses in Wis. Stats. § 125.12 provided there is cause for disciplinary proceedings under the relevant ordinances or statutes.

9/2/2006 On 09-02-06 at 12:23 A.M., the Racine Police SWAT team executed a "No Knock" search warrant at Sabrina's, 1436 Junction Avenue. The Racine Polcie Gang Unit developed reliable information that controlled substances were being sold inside Sabrina's Bar. Specifically, the target selling the controlled substances was said to be George Owens, and that he had an armed guard at the front door and behind the bar. The valid "No-Knock" search warrant was obtained and executed on 1436 Junction Avenue, which included the bar and upper apartment. Upon executing the search warrant, memebers of the SWAT team observed Aaron D. Samuels, dropping a gun and drugs into a trash can while SWAT was making entry. Samuels was subsequently

arrested. The Racine Police Gange Unit recovered in excess of 25 grams of Marijuana, 2 handguns and in exces of \$300.00 in U.S. Currency. The owner, George D. Owens, was present during the execution of the search warrant, and when the 2 guns and drugs were in his bar. When officers released the bar back to Owens, he stated that he was tending bar and that his girlfriend owned the bar. No contraband was located on Owens' person. There were six (6) individuals arrensted as a result of the search warrant, and over 20 people in the bar at the time the search warrant was executed.

6/23/2006 Laws reported that he had been inside Sabrina's and stepped outside to have a cigarette and go to his car. A black male walked past, turned and began shooting. Laws turned and ran inside the bar. Once inside, he noticed that he was bleeding and told his cousin, Prentis W. Hollimon. Bar personnel refused to call police and patrons began to run out of the bar. Hollimon and Laws exited the rear door and Hollimon called police from this cell phone. At lthe same time, he observed an officer on another call and flagged him down. Laws did give a rather detailed description of the shooter. When the oficer was providing aid to Laws, he did observe two (:2) black males run from the rear of the bar to Ann Stret and enter a waiting vehicle. The vehicle was not located by other responding officers. Laws was transported by RFD Rescue to SMMC and treated for a single gunshot wound to his abdomen. Jeanette Owens (the cook) stated she was by the grill and idi not se or observe anything. George Owens stated he heard an echo of a shot, observed people running into the bar and toward the back of the bar knocking over/breaking glasses. A scene was located outside and one (1) projectile was recovered. During the follow-up investigation, Laws stated he was very drunk and couldn't be sure of what happened. Some details changed but his description of the core action of the shooting remained the same. When he and Hollimon arrived in the bar a party was going on. They had heard that many of the patrons were from out of town - possibly Green Bay. Laws believed the shooter had been in the bar earlier but could not be sure. The investigation is "Dormant." It will be re-opened if new leads area developed. ATTEMPTED **HOMICIDE**

5/20/2006 An anonymous female called stating Sabrina's has been serving minors - her daughter has come home drunk from there. Not an active complaint - information was sent for extra attention to the patrol sergeants. LIQUOR VIOLATION
