The Racine Fire Department's proposed hiring process:

- Applications after 2019 testing Human Resources will have open application process via NeoGov with pre-determined cutoff date for future test eligibility. Testing on an as needed basis.
- Written Exam Follow FPSI scoring recommendations (pass/fail) with considerations.
 Failing candidates removed from consideration, all other candidates remain on eligibility list. Some candidates may not receive an initial interview however subject to later interview.
- **Panel Interview** Internal panel of both Chief Officers and Local 321 representatives, number of candidates based upon projected openings (develop ratio, 3:1, 5:1), candidates based on test score and other demographics.
- **CPAT** Send candidates who successfully pass Panel Interview to CPAT. Any candidate with current CPAT will proceed directly to background investigation.
- **Background Investigation** background investigations to be completed on all candidates who successfully pass the panel interview and CPAT.
- **Police and Fire Commission Interview** candidates must successfully pass the panel interview, CPAT, and background investigation to interview with the PFC.
