1. How do I qualify for an operator's license?

To qualify for an operator's license, you must

- o Be at least 18 years old
- o Meet criminal record requirements (please ask the clerk's office for a complete copy of criminal
- Have completed a responsible beverage server training course
- Pay the \$90 application fee
- Turn in a completed operator application

2. What are responsible beverage server training courses?

Not all responsible beverage server training courses are taught by technical colleges. Other courses (see "Training" on the Department of Revenue website) may be substituted for those taught at technical colleges, as long as they have been approved by the Department of Revenue or the Department of Safety and Professional Services (DSPS). Make sure of this approval before enrolling in a responsible server course not offered at a technical college.

3. What exceptions are there to the server training course requirement?

The exceptions to this requirement are

- o If you are renewing a current operator's license
- o If you were the agent of a corporation that held a Wisconsin retail license within the past two years
- o If you held a Wisconsin retail or operator's license within the past two years
- o If you completed a Wisconsin approved server training course within the past two years.
