Count 1: TOBACCO DISTRIBUTOR FAIL/LICENSED

The above-named defendant on or about Thursday, November 16, 2017, in the City of Racine, Racine County, Wisconsin, did engage in the business of a distributor or subjobber of tobacco products at a place of business without having filed an application for and without having obtained a permit to engage in that business at such place, contrary to sec. 139.79(1), 139.44(5) Wis. Stats., a Misdemeanor, and upon conviction shall be fined not less than \$100 nor more than \$1,000 or imprisoned not less than 10 days nor more than 90 days or both.

Count 2: ATTEMPT TO EVADE CIGARETTE OR TOBACCO TAX

The above-named defendant on or about Thursday, November 16, 2017, in the City of Racine, Racine County, Wisconsin, did make or sign a false or fraudulent report or attempted to evade the tax imposed by s. 139.31 or 139.76 or aided or abetted the evasion or attempted evasion of that tax, contrary to sec. 139.44(2) Wis. Stats., a Misdemeanor, and upon conviction may be fined not more than \$10,000 or imprisoned for not more than 9 months or both.

Count 3: TOBACCO MANUFACTURER FAIL/KEEP RECORDS

The above-named defendant on or about Thursday, November 16, 2017, in the City of Racine, Racine County, Wisconsin, did, as a distributor or subjobber, fail to keep accurate and complete records of purchases and sales of tobacco products, contrary to sec. 139.82(1), 139.44(3) Wis. Stats., a Misdemeanor, and upon conviction shall be fined not less than \$100 nor more than \$500 or imprisoned not more than 6 months or both.

Count 4: CIGARETTE RETAILER FAIL TO KEEP RECORDS - 1ST OFFENSE

The above-named defendant on or about Thursday, November 16, 2017, in the City of Racine, Racine County, Wisconsin, as a licensed retailer, did fail to keep complete and accurate records of all purchases and receipts of cigarettes and tobacco products and failed to keep two years of such records
